

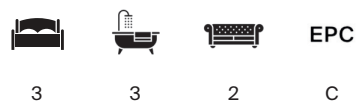

Set on one of Pimlico's most desirable garden squares, this beautifully presented apartment offers well-balanced accommodation with excellent natural flow.

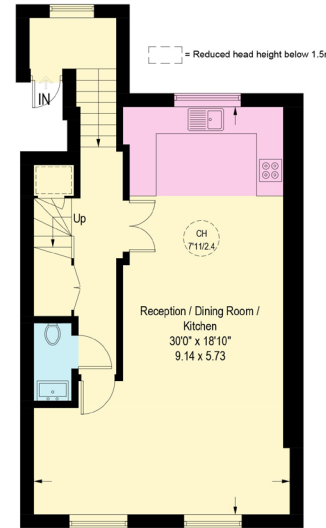

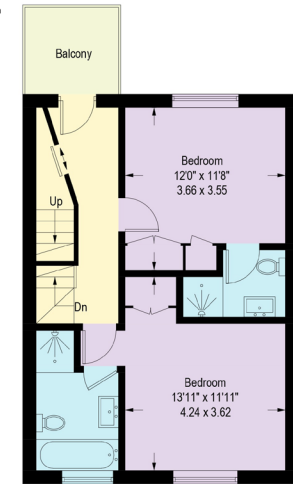

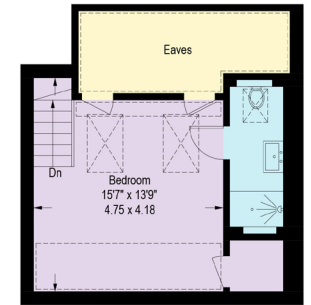
