ABOUT THE PROPERTY

The development is located in prime position at the rear of the Coed Parc "Old Library" Grade 2 listed deployment. When completed Coed Parc Rise will be accessible from Walters Road. The development is set in an executive and attractive grounds surrounded by mature woodland.

The property will feature all windows Anthracite on the outside and white on the inside and an aluminium front door in Anthracite. 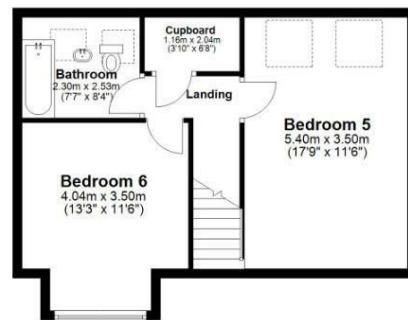

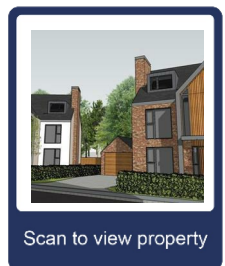
