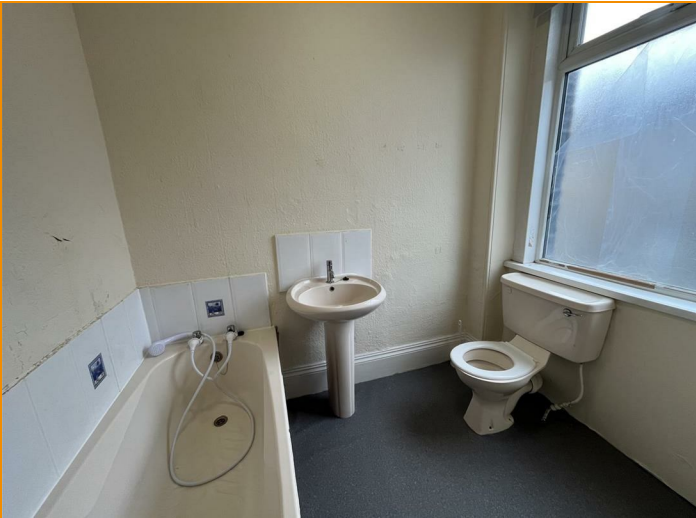

GROUND FLOOR

KITCHEN
