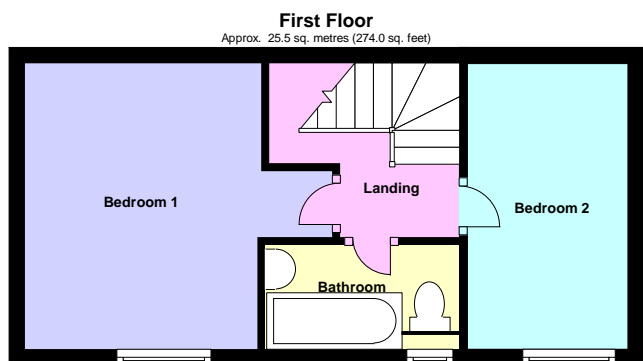
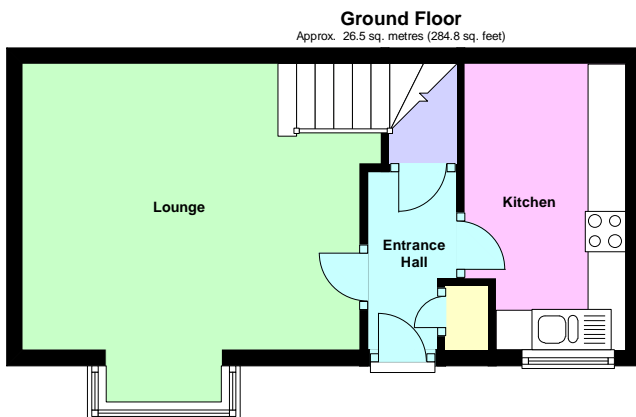




Senwick Drive Wellingborough NN8 1SD

Situated within minutes walking distance of the railway station with access to London St. Pancras International within the hour is this two bedroomed property which benefits from gas radiator central heating, uPVC double glazing, built in kitchen appliances, a refitted bathroom suite and offers off road parking. The property is available from 1st July 2023, subject to references. The accommodation briefly comprises entrance hall, kitchen, lounge, two bedrooms, bathroom and garden to front.

#### **Tenant Requirements**

- First month's rent of £850 pcm
- Deposit of £980.77
- Your details will be submitted to our referencing company, who will carry out a credit check and obtain previous landlord references and employment references
- Proof of identification (passport or driving licence and proof of address i.e. utility bill)
- Right to remain documents (if applicable)
- Holding deposit of £196.15 (one weeks' rent). This is to reserve a property, subject to referencing. Please note: This will be retained if any relevant person (including any guarantor(s)) withdraw from the tenancy, fail a Right-to-Rent check, provide materially significant false or misleading information, or fail to sign their tenancy agreement (and/or Deed of Guarantee) within 15 calendar days (or other Deadline for Agreement as mutually agreed in writing). This holding deposit will be returned within 15 days or apportioned to rent with the prospective tenants consent if referencing is successful.
