Double glazed window to rear, central heated radiator.



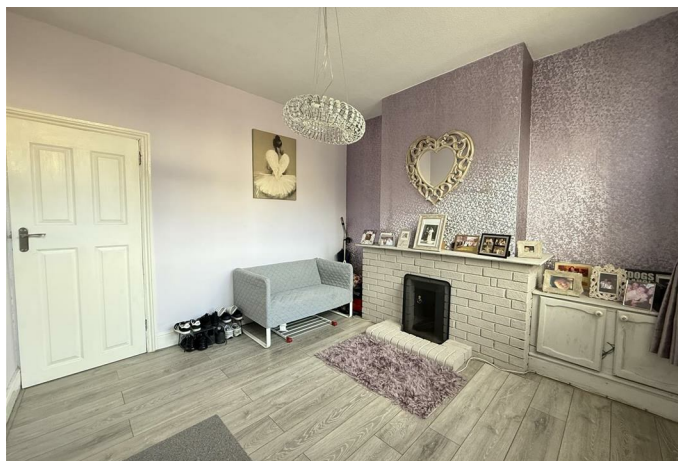
Inner Lobby

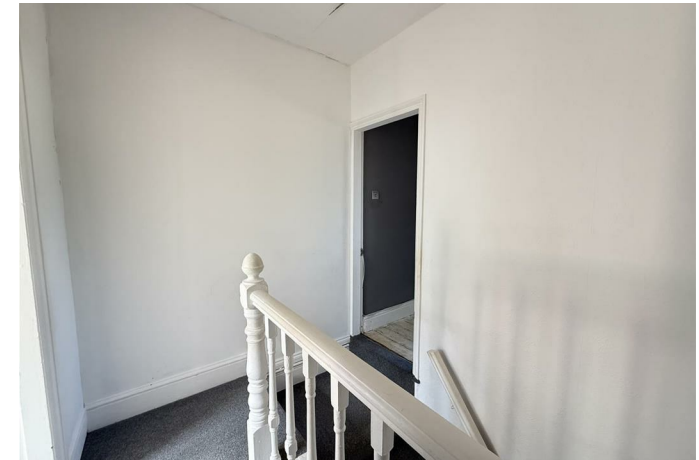

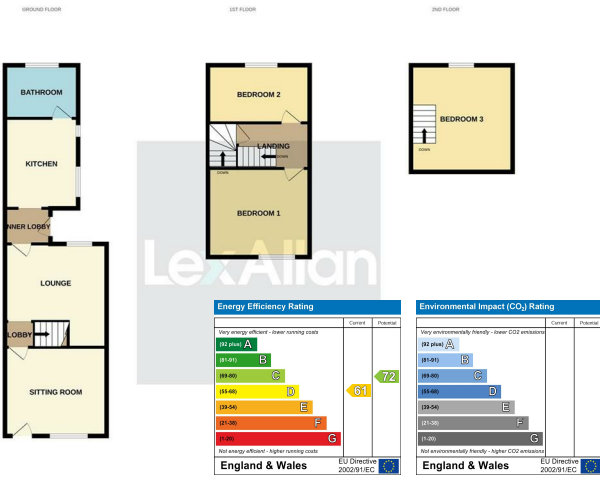
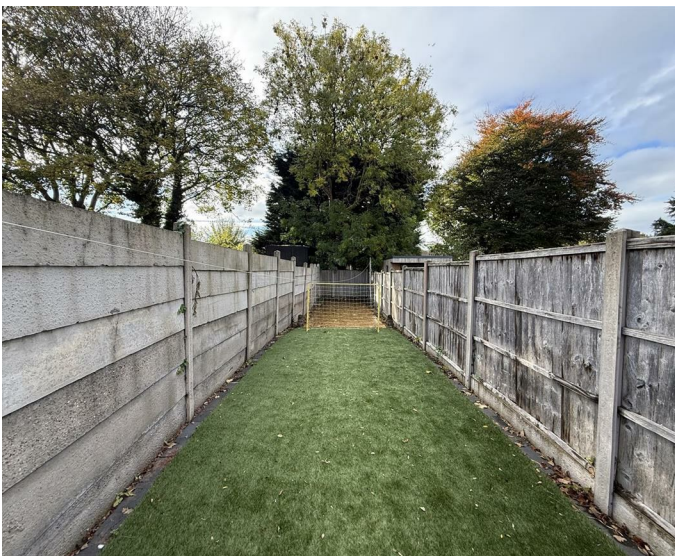
