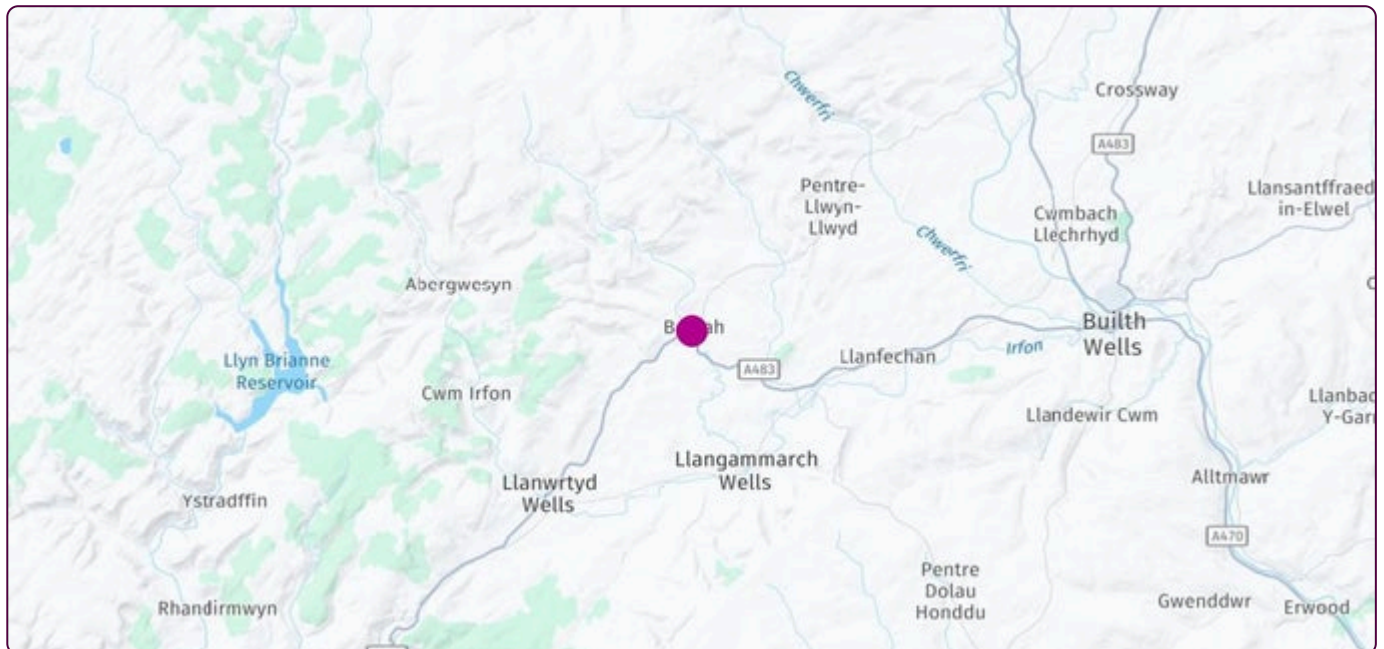
DESCRIPTION

LOCATION

Nestled in the heart of Wales, the Trout Cafe and Petrol Filling Station is a stone's throw away from the Cambrian Mountains, whose hidden delights include the Devil's Staircase and the Llyn Brianne Reservoir, with scenery rivalling that of the nearby Elan Valley. The Trout Cafe and Filling Station is located on the busy A483 which benefits from constant traffic.

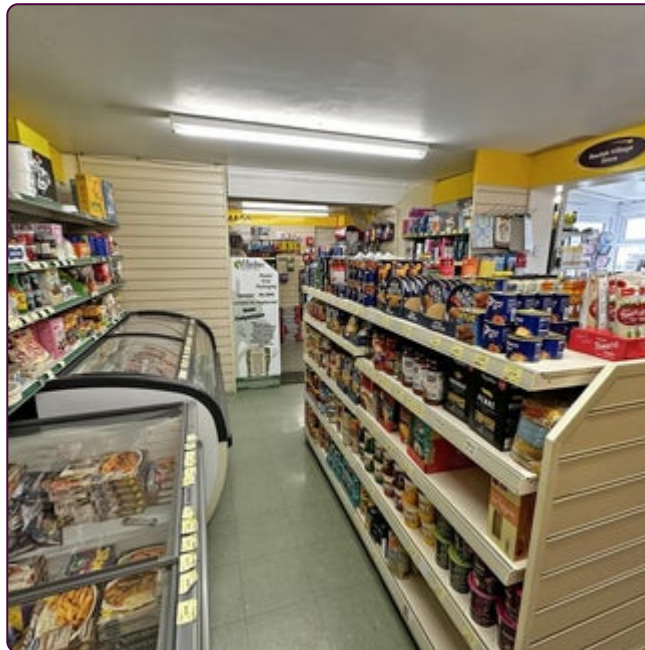


THE OPPORTUNITY

The current owners have owned The Trout Café & Petrol Filling Station since 2014 and have improved trade and business. The owners acquired the convenience store and petrol filling station in 2019 and again have improved trade and have kept the premises well maintained.

The forecourt presents an excellent opportunity to acquire a well-sized site with great development potential and a strong retail business, with the scope to increase trade. Along with a well-renowned Café and bed and breakfast. There are five letting rooms in total along with two apartments which could all provide further income.

There is the opportunity to introduce a variety of product ranges and promotions, hot food options, and forecourt services to help increase turnover and gross profit margins.



INTERNAL DETAILS

This is a unique opportunity to acquire a freehold site that includes, a petrol filling station, convenience store, café, five letting rooms and two apartments. The Trout Café makes the most of the fresh ingredients Wales has to offer, by serving traditional homemade meals, along with a good selection of beers, wines, and soft drinks in a cosy environment. The main counter/bar is directly in front of the entrance, with seating and a traditional fireplace setting on the left, further seating area on the right and a separate function room that is available for private hire. Above the café, you will find five double rooms all with ensuite bathrooms. The Trout Café currently offers a reputable Bed and Breakfast service, which brings in additional income.

Above the store, you will find the owner's accommodation, which comprise three bedrooms, two bathrooms, kitchen and living room, which is ideal either for an owner-operator or could be used as extra income as a rental.

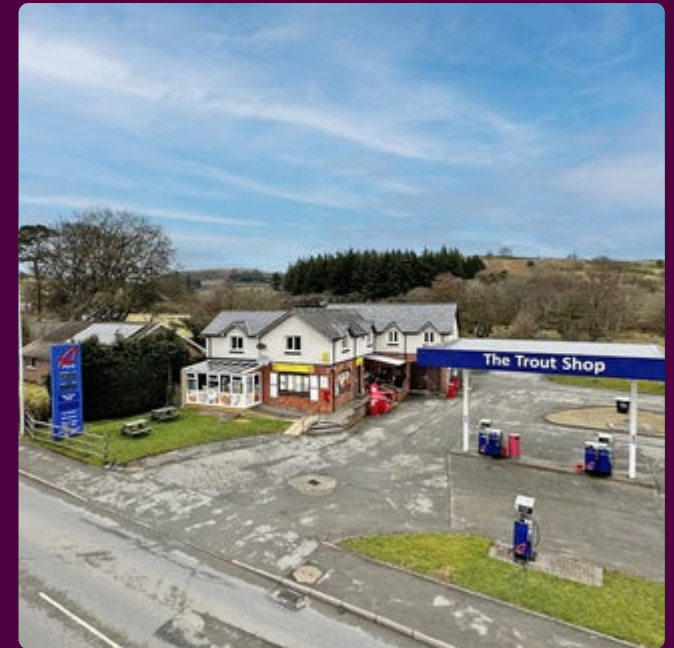
