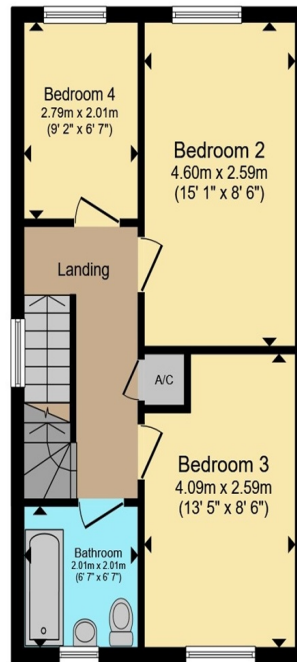




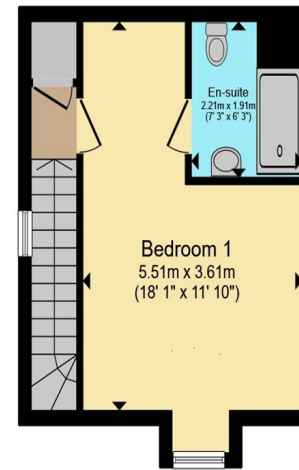




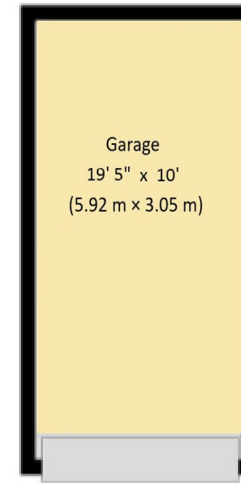
Ground Floor
