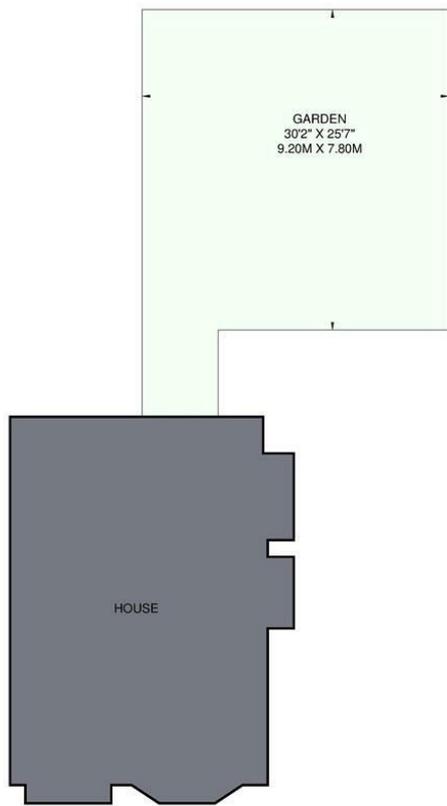

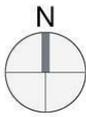

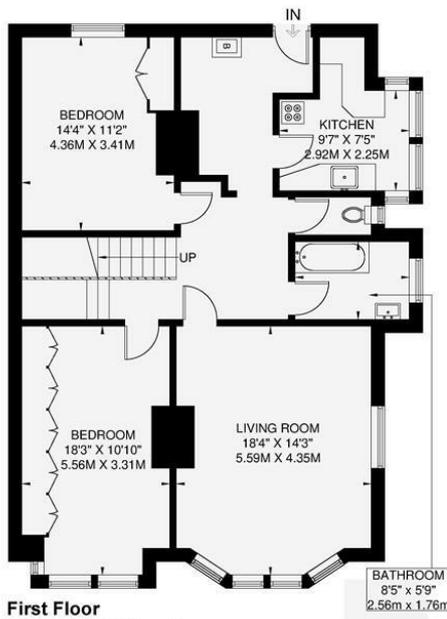

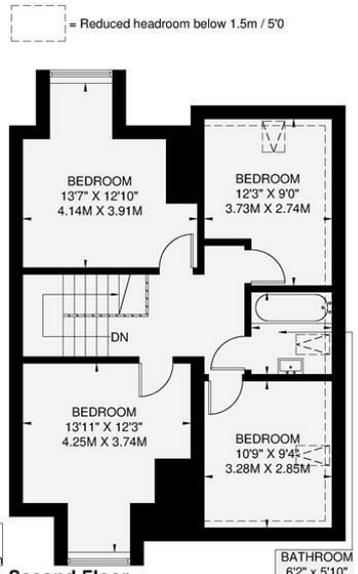
Site Plan
