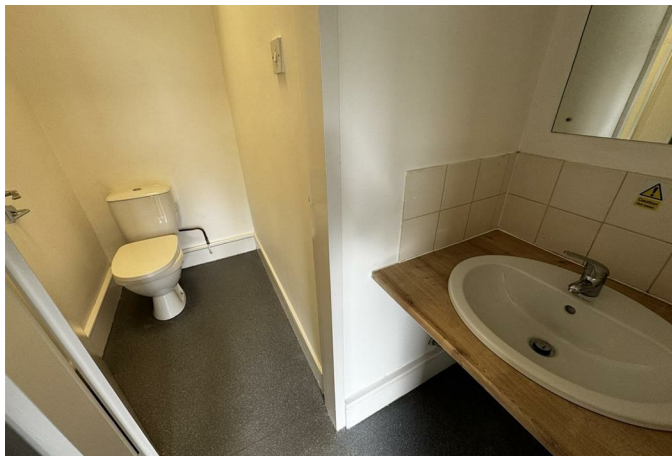

FULL DESCRIPTION

The premises are situated within the Yarm Road Business Park, which is one of the key trading estates in Darlington. In recent years, this estate has gained popularity due to a combination of new developments that offer a variety of accommodations to meet the needs of most commercial property sectors.

The estate has become favoured because of its close proximity to the A66, which offers excellent connections to Teesside, as well as the region's major highways, the A19 and A1(M).

The premises consist of a single-storey brick office building that features a blend of open-plan and partitioned offices, along with an entrance/reception area and staff amenities. The premises are equipped with suspended ceilings, perimeter trunking with networking facilities, double glazing throughout, air conditioning unit, gas fired central heating, large carpark,, secure padlocked gates, CCTV and alarm.
