House - End Terrace



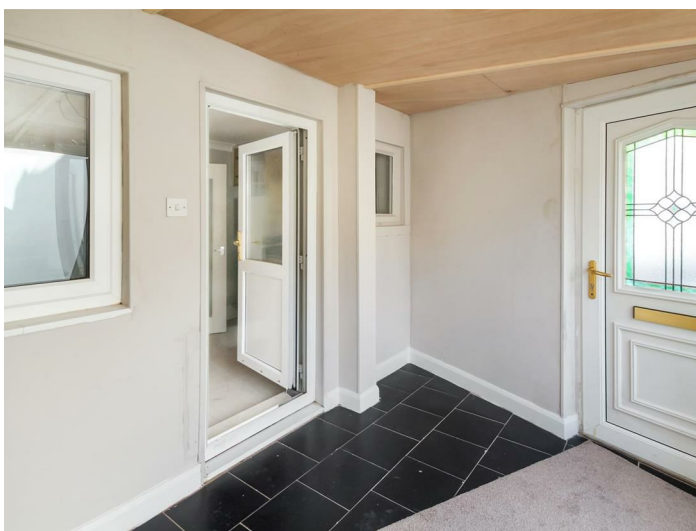
A very well presented and much improved traditional terraced house, offering surprisingly spacious accommodation and an excellent opportunity for either the owner occupier or property investor. The property is particularly conveniently situated within easy reach of Darlington town centre and the railway station, making it well placed for access to the town's amenities, transport links and wider area.

The accommodation comprises an entrance hallway leading into a lovely lounge, with a separate dining room and a well fitted kitchen having a good range of floor and wall units, complemented by attractive marble worktops. To the first floor there are three good size bedrooms together with a bathroom which has been refitted with a modern white suite incorporating a shower.

Outside, the property benefits from an enclosed yard to the side.

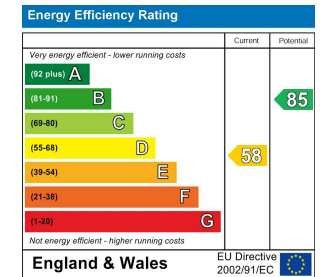
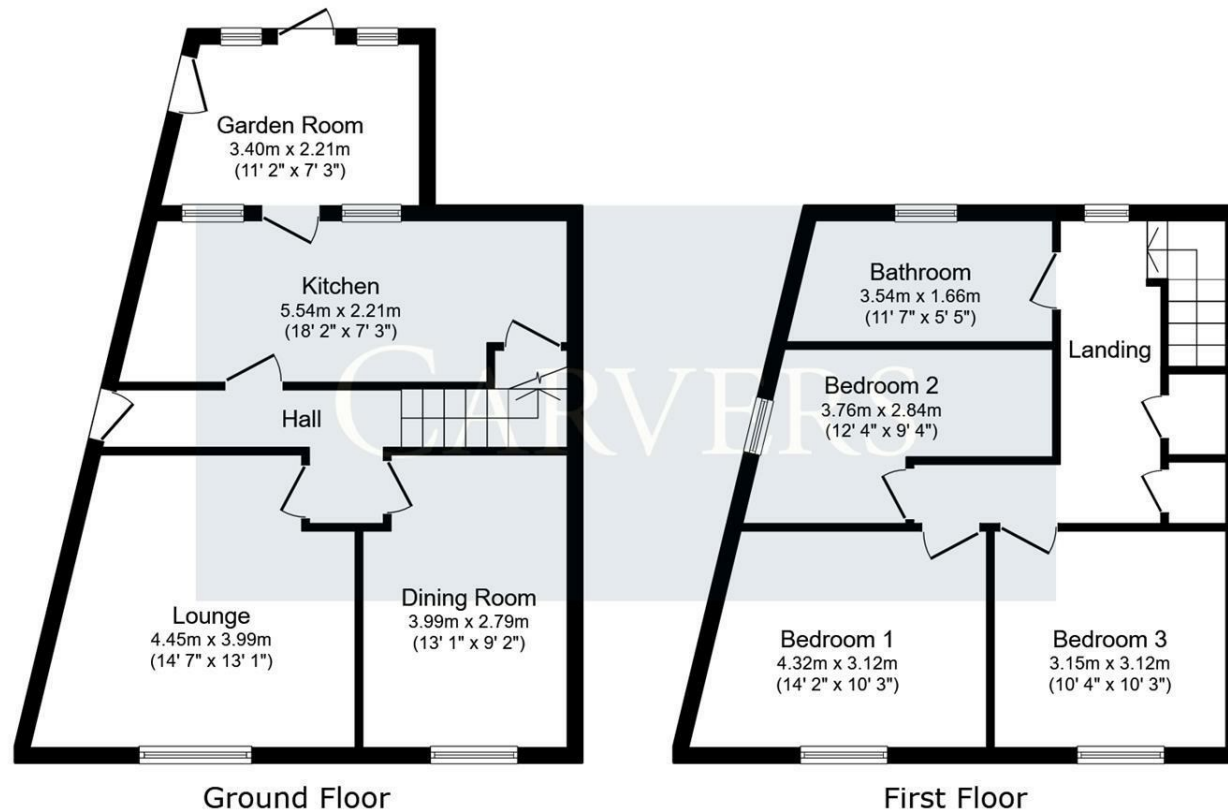
