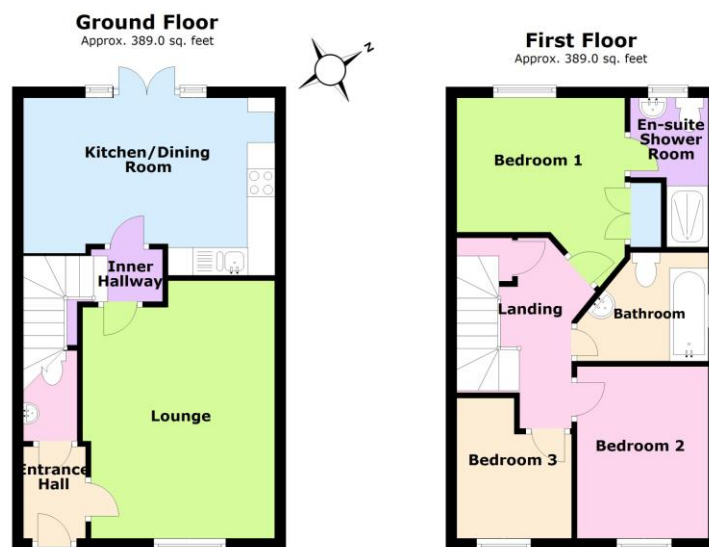




## Chimney Crescent Irthlingborough NN9 5WF

- Proof of identification (passport or driving licence and proof of address i.e. utility bill)
- Right to remain documents (if applicable)
- Holding deposit of £229.61 (one weeks' rent). This is to reserve a property, subject to referencing.
