Tan y Fron is a fine example of an Arts and Crafts movement house and retains many of its original features including coving; picture rails; deep skirting boards; doors and fireplaces, even the original decorative stained glass window has been fitted into a upvc frame. It was built for the youngest daughter of the Count and Countess of Morella (of Spanish descent). Her mother was the main landowner of the village at that time, her name is in the village church and she paid for the village monument to be built. Tan y Fron was built in sight of Hendre Hall where they resided.

Situated on a private residential lane off the main street with enclosed grounds and gated entrance to a gravel driveway and parking for several vehicles. The house comprises a large entrance hallway, lounge with reading room, dining room open to the kitchen, utility and cloakroom on the ground floor. With 4 double bedrooms, bathroom and separate w c on the 1<sup>st</sup> floor. The property is oil centrally heated and fully upvc double glazed.

Llwyngwril is a small and stunningly beautiful village on the shores of Cardigan Bay. The village has a shop and pub. There is a daily bus and mainline rail service. Tywyn, which is approximately ten miles away boasts its own leisure centre and swimming pool complex plus all the usual facilities including a cinema, cottage hospital and high school. For golfing, boating and all water sports the delightful harbour village of Aberdovey is just fourteen miles away along the coast past Tywyn towards Pennal and Machynlleth.
