Anti-Money Laundering Checks

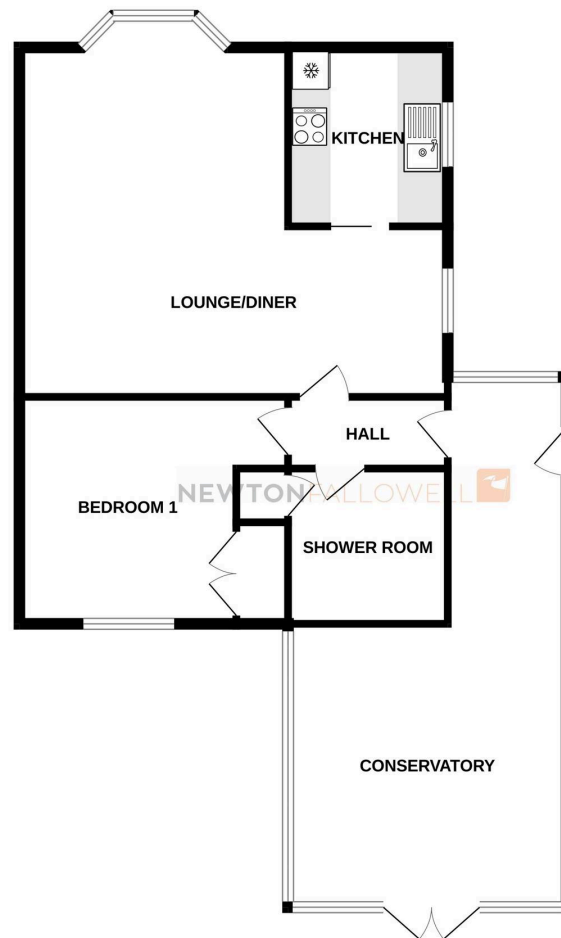
