THE PROPERTY

This characterful and light filled mid terrace cottage offers well proportioned accommodation. The ground floor comprises an entrance porch leading into the kitchen, fitted with a two door oil fired AGA, separate electric oven and hob and space for a dishwasher and fridge freezer. To the front of the cottage is a generous sitting room with a wood burning stove, built in shelving to either side and windows overlooking the front and rear garden. The kitchen leads to a small inner hallway with understairs storage, a cupboard housing the boiler and plumbing for a washing machine and access to the dining room/study at the rear of the property with a door leading to the garden and lovely views.

A newly carpeted staircase rises from the hallway to the spacious landing leading to two double bedrooms, both with built in storage cupboards and a bathroom

with separate shower and heated towel rail.

Outside there is a small front garden and a large terrace with a lawned garden to the rear bordered by mature shrubs with stunning views across the open fields.

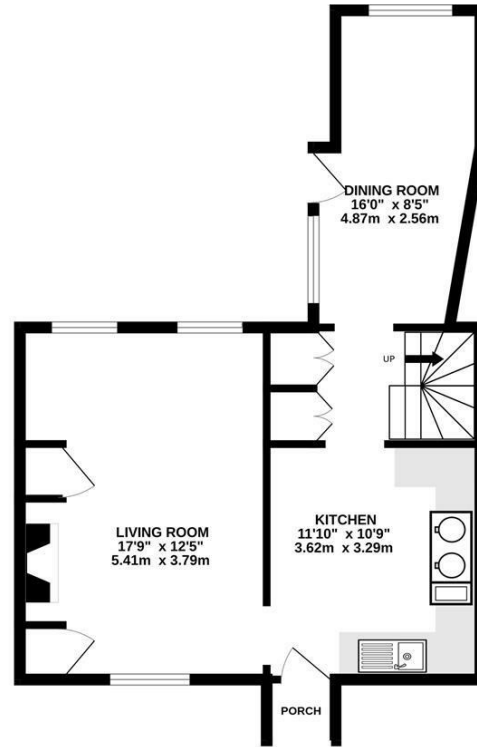

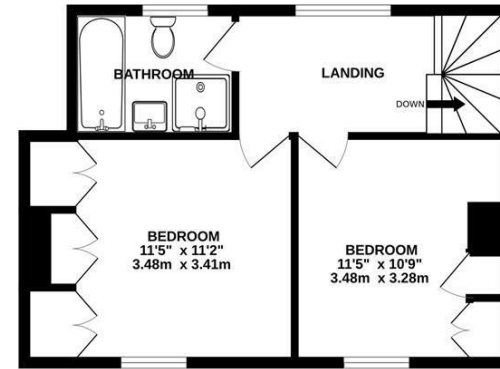
