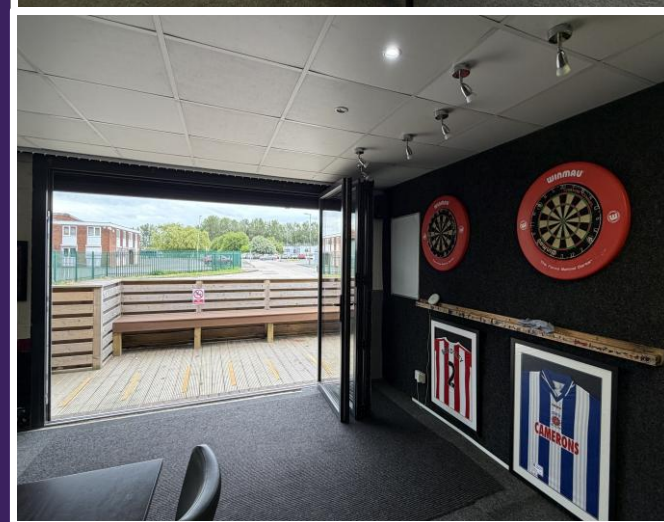
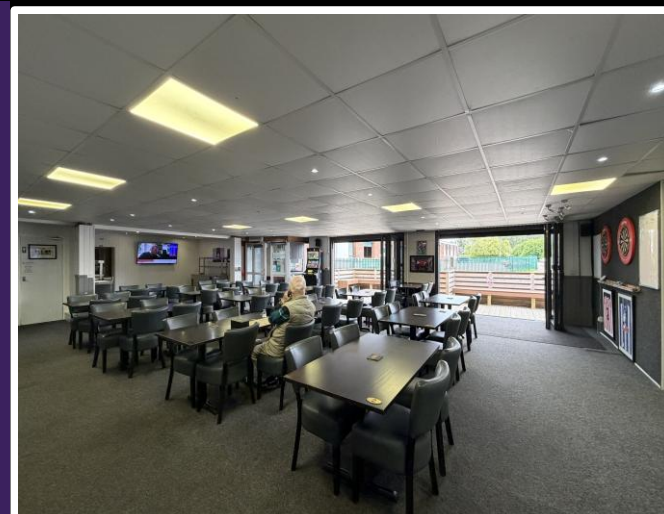

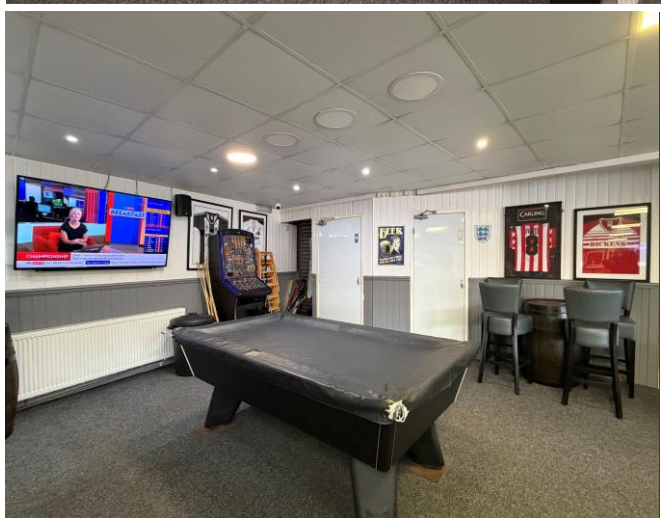
Further accommodation includes office facilities, beer cellar/storage areas, ancillary stores, preparation rooms and customer and staff W.C. facilities.

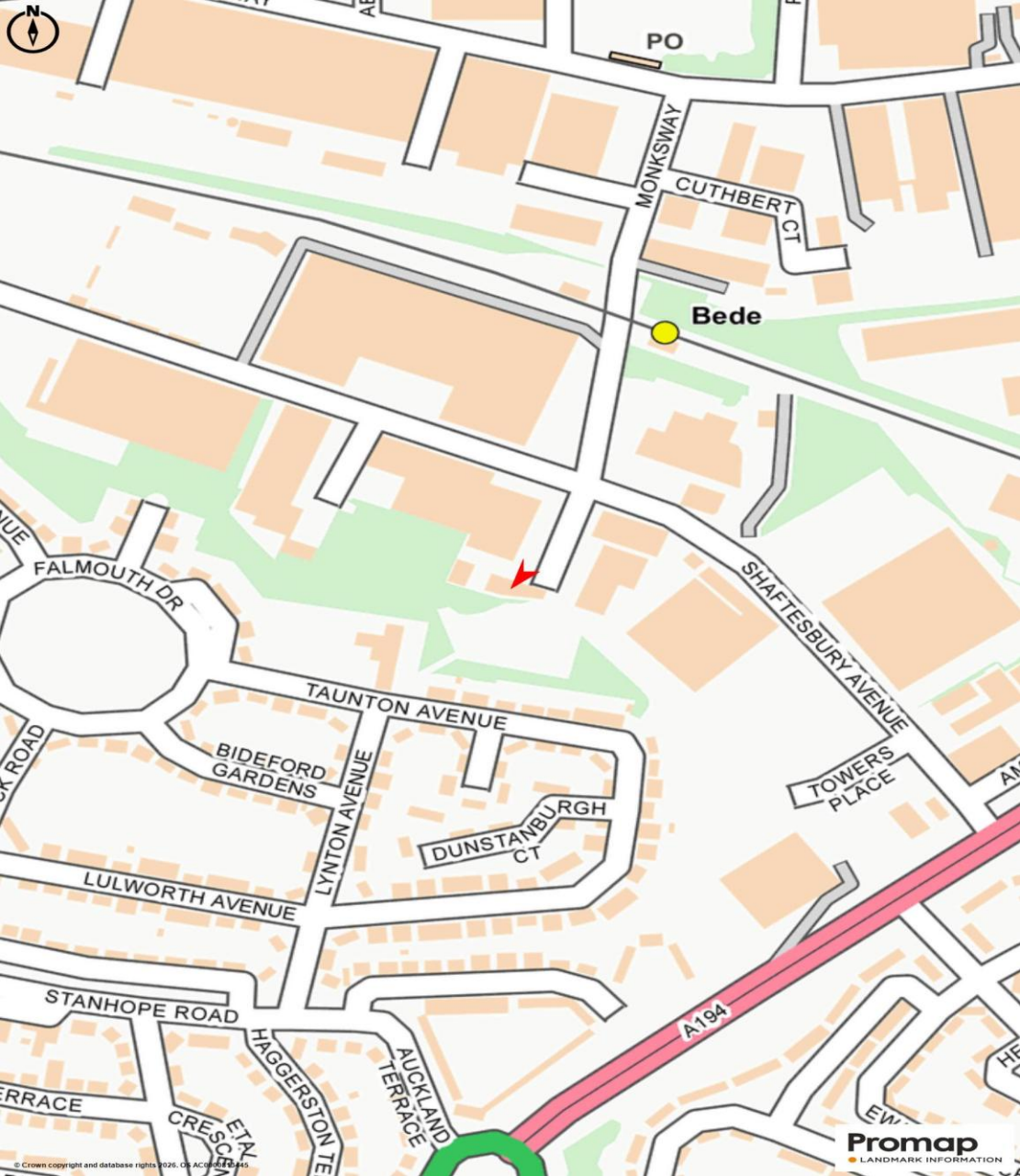

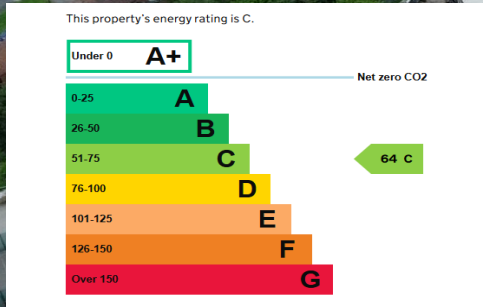
