BROUGH

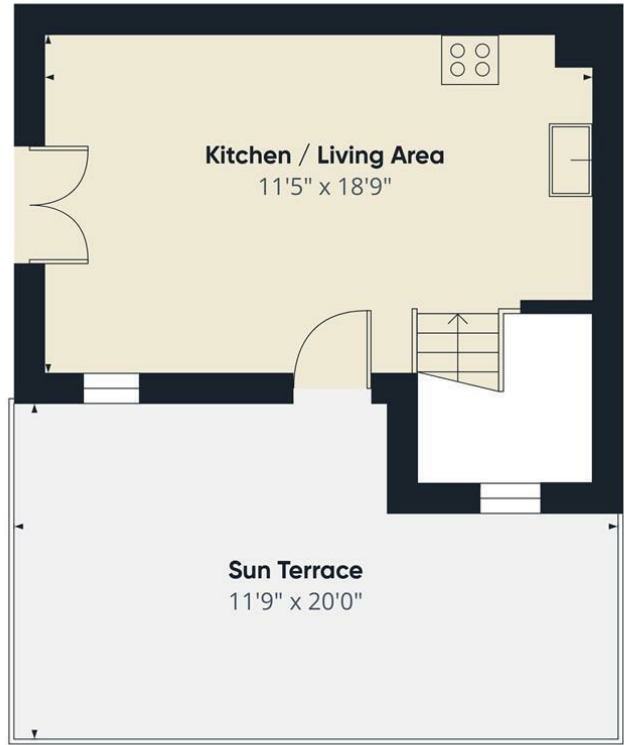
