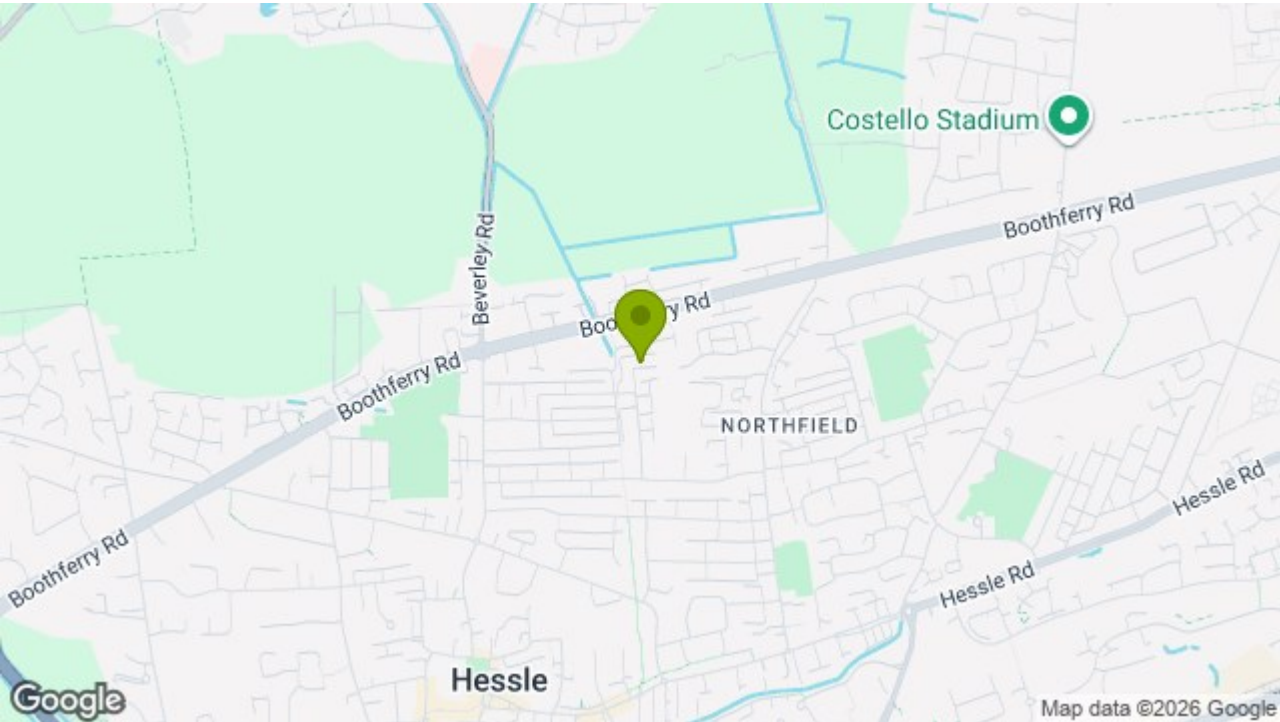

HESSLE

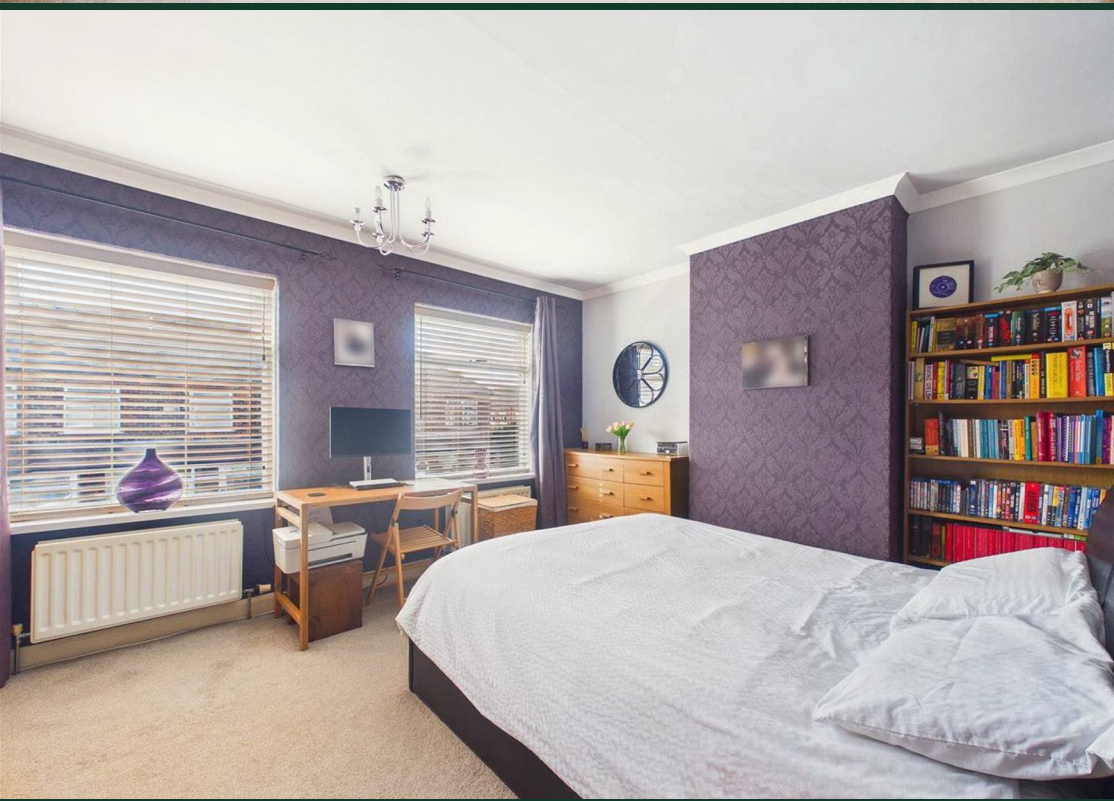
