The ground floor retail shop is currently let as a dog grooming parlour on a 5 year lease commencing 1st August 2024 at £9,000 per annum (+vat). It has an internal floor area of about 53m².

The maisonette above is vacant and comprises on the first floor; landing, lounge, kitchen, bedroom and bathroom. On the second floor; large landing/study area and bedroom. There is electric heating. Potential income of about £10,800 per annum.

At the rear is an enclosed garden mainly laid to lawn with a useful outbuilding.

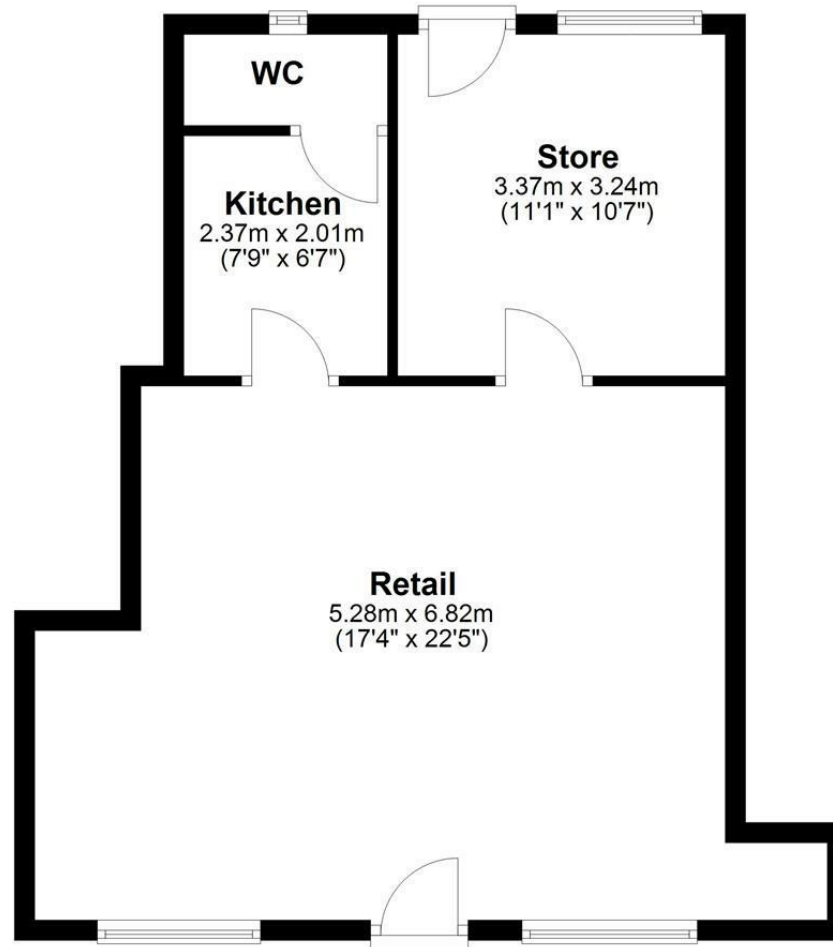
Legal Pack
