uPVC double glazed window to the rear elevation, door giving access to stairs rising to first floor accommodation with uPVC double glazed window to the side elevation.

KITCHEN 8'7" x 6'9" (2.62m x 2.06m)

uPVC double glazed window to the side elevation, fitted kitchen comprising base, drawer and wall units with complementary work surface, tiled splashback, inset stainless steel sink and drainer with mixer tap, integrated electric oven and four ring electric hob with extractor over, space for low level appliance and doorway giving access to:

uPVC double glazed windows to both the rear and side elevations, radiator and wall mounted gas fired central heating boiler.

Gated access leads to the side of the property to the enclosed low maintenance walled yard.

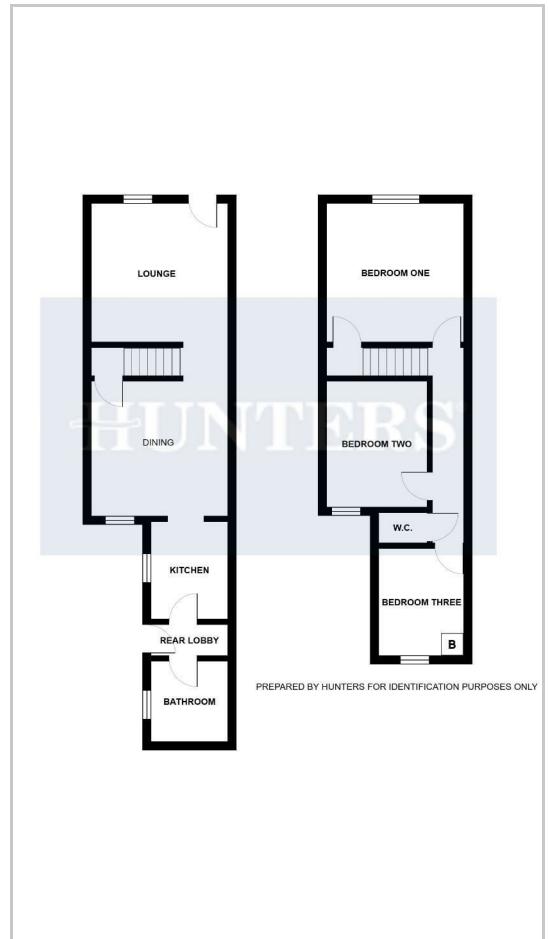
