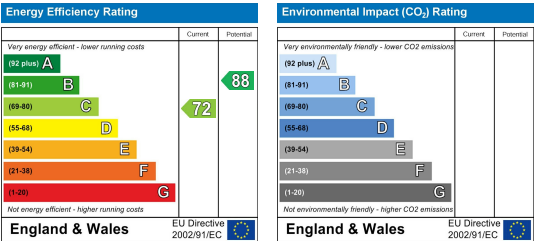
Floor Plan
