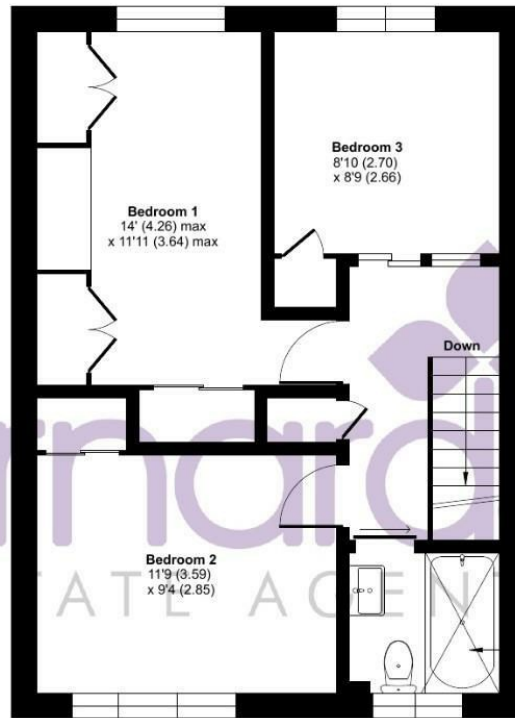

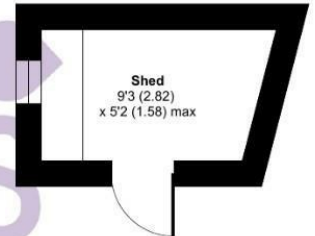

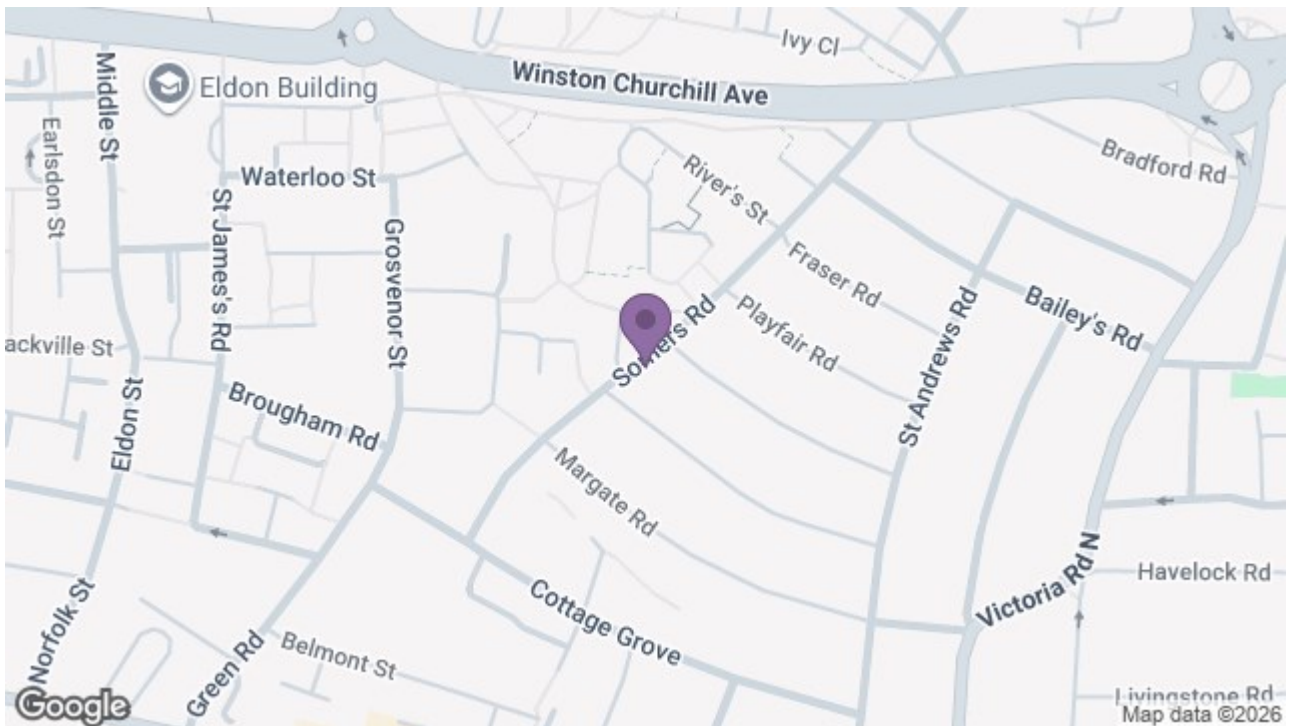
FIRST FLOOR
