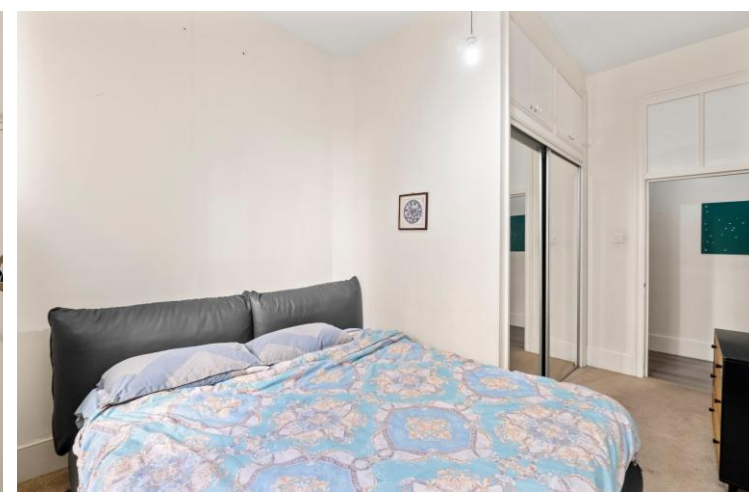

A large lateral apartment, walking distance to amenities on High Street Kensington & the newly refurbished Kensington Olympia.

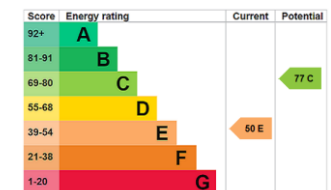

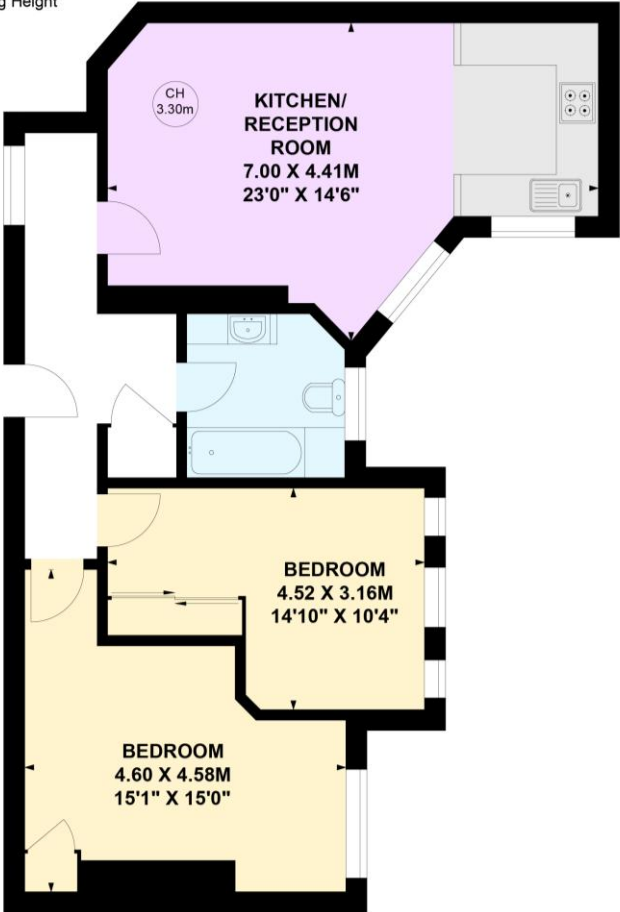
