Description

Situated in this convenient cul de sac location just off Simms Lane in Hollywood this mid terraced property offers generous family accommodation close to the local amenities of Hollywood and Wythall.

There is well regarded schooling at Coppice Primary and Woodrush Academy both of which are cited nearby on Shawhurst Lane. Education facilities are subject to confirmation from the Education Department. There is the benefit of local shops at Drakes Cross Parade and easy road access to the Alcester Road in Hollywood which in turn provides access to junction 3 of the M42 motorway, forming the hub of the midlands motorway network.

The property is situated within easy access to Shirley along Truemans Heath Lane and one can continue back through Hollywood to Sainsbury's at the Maypole island, which also provides access to Birmingham city centre and the southern Birmingham suburbs. There are railway stations nearby at Wythall and Whitlocks End offering commuter services between Birmingham and Stratford upon Avon, and local bus services provide access to the City of Birmingham.

Set back from the road via a full width block edged tarmacam driveway a UPVC double glazed door opens into the porch with further door into the hallway with a turned staircase rising to the first floor accommodation and doors to the lounge with UPVC double glazed double doors to the rear garden, kitchen with door to the side passage way having a ground floor wc and access to the front driveway and rear garden.

On the first floor accommodation there are three double bedrooms and a modern bathroom.

The rear garden has decked and gravel patio areas, artificial lawn, flower and shrub borders, summer house currently used as a gym, store and fencing to boundaries.

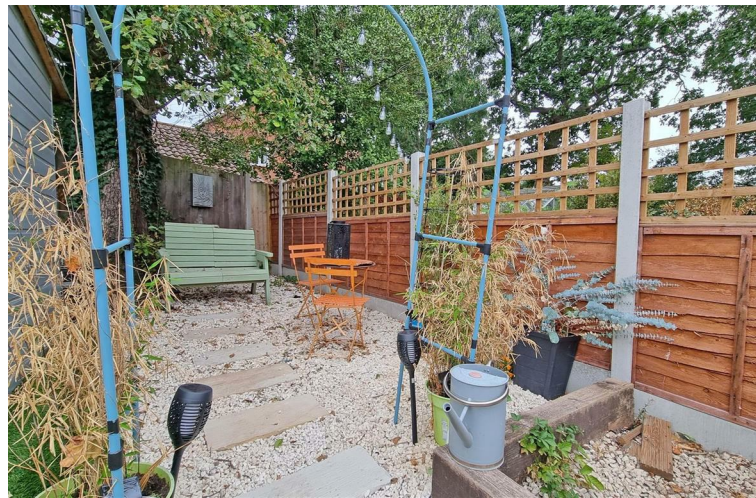

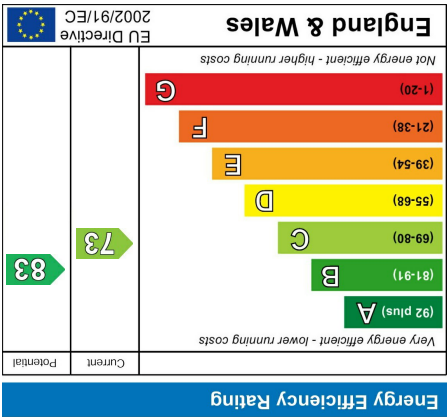
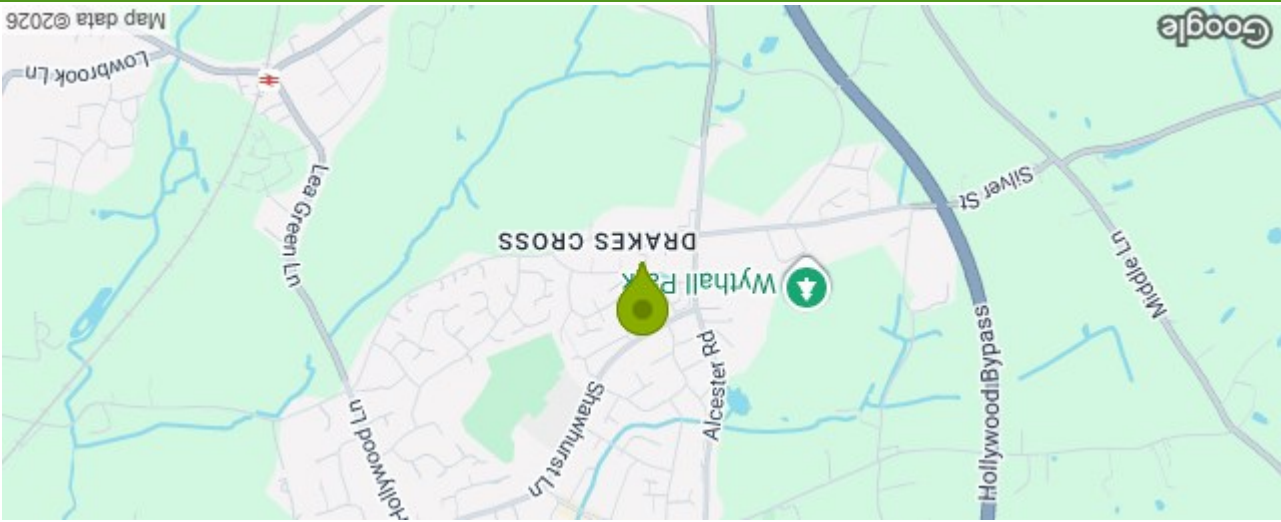
