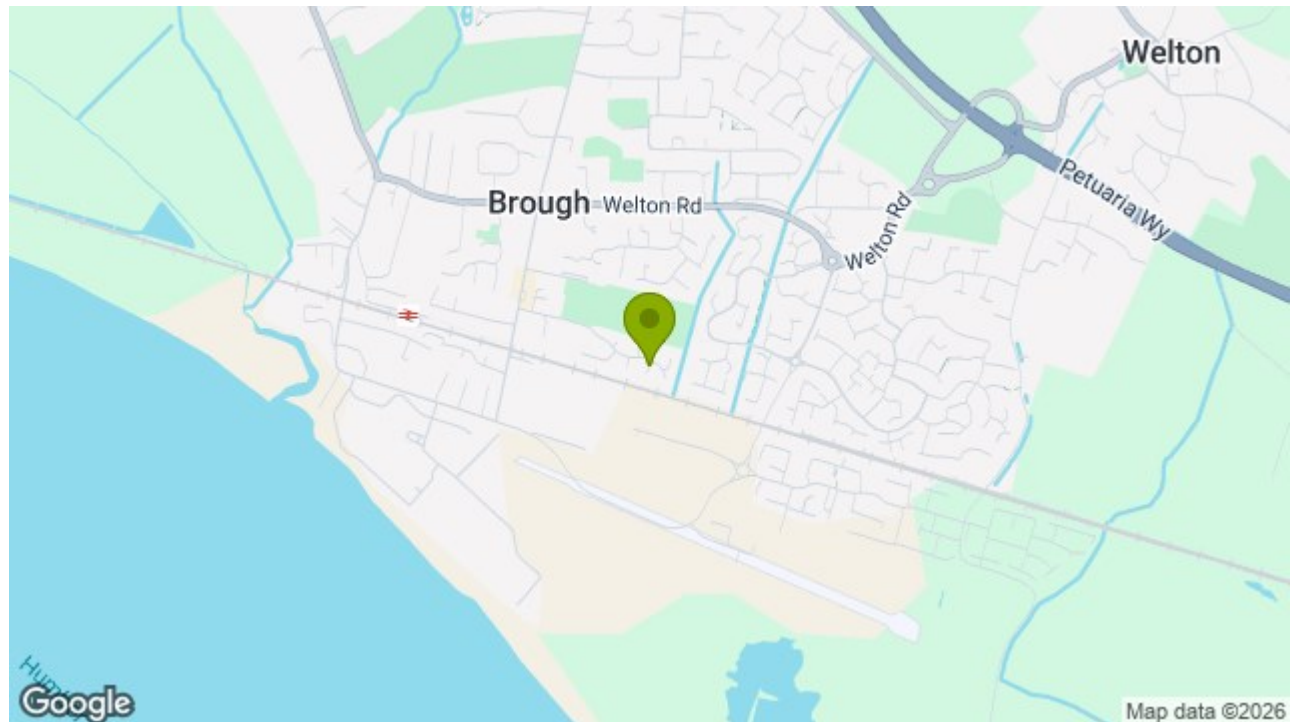

ACCOMMODATION

The accommodation is arranged over two floors and comprises:

GROUND FLOOR

KITCHEN

The modern kitchen is fitted with a range of white fronted base units with complementary worksurfaces beneath splashbacks. A sink unit sits beneath a window to the rear and there are integral appliances which include an electric oven, ceramic hob and extractor hood along with a slimline dishwasher. There is space and plumbing for an automatic washing machine and space for a larger fridge freezer. A staircase leads to the first floor and there is a composite entrance door.

FIRST FLOOR

LOUNGE

A spacious first floor reception room with windows to the front and rear elevations. There is a built-in storage cupboard.

DOUBLE BEDROOM

A double bedroom with a built-in wardrobe and a window to the front elevation.

SHOWER ROOM

A contemporary shower room which is fitted with a three piece suite comprising WC, counter-top wash basin with a tiled splashback and a large walk-in shower cubicle with a tiled inset. There is a heated towel rail and a window to the rear.

OUTSIDE

PARKING

There is 2 allocated parking spaces within a courtyard.

GENERAL INFORMATION.

SERVICES - Mains water, electricity, gas and drainage are connected to the property.

CENTRAL HEATING - The property has the benefit of a gas fired central heating system to panelled radiators.

DOUBLE GLAZING - The property has the benefit of PVC double glazed frames.

COUNCIL TAX - From a verbal enquiry/online check we are led to believe that the Council Tax band for this property is Band A. (East Riding Of Yorkshire). We would recommend a purchaser make their own enquiries to verify this.

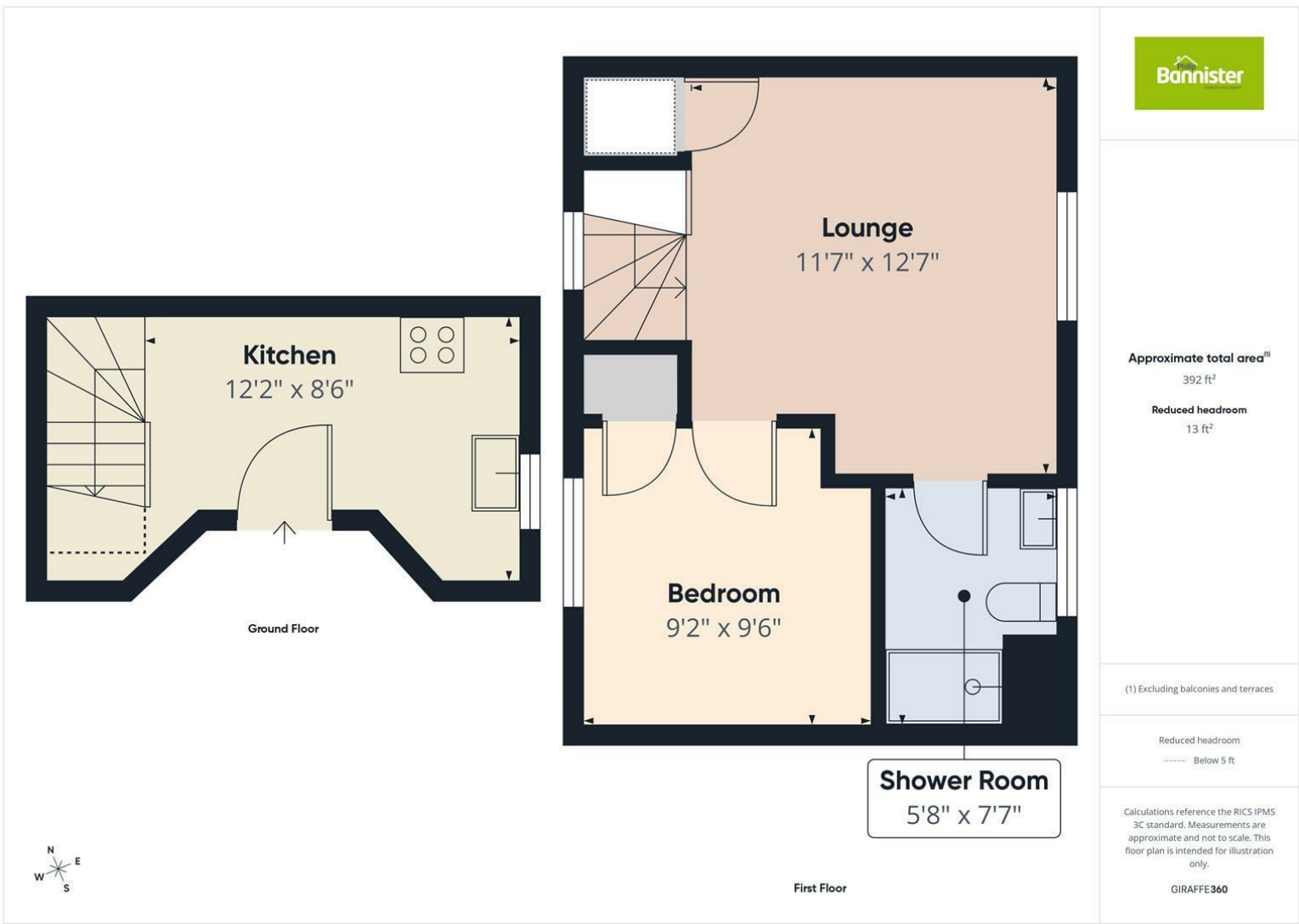
