A bright and airy second floor purpose built flat situated moments from Southfields Underground station on the ever popular Wimbledon Park Estate.

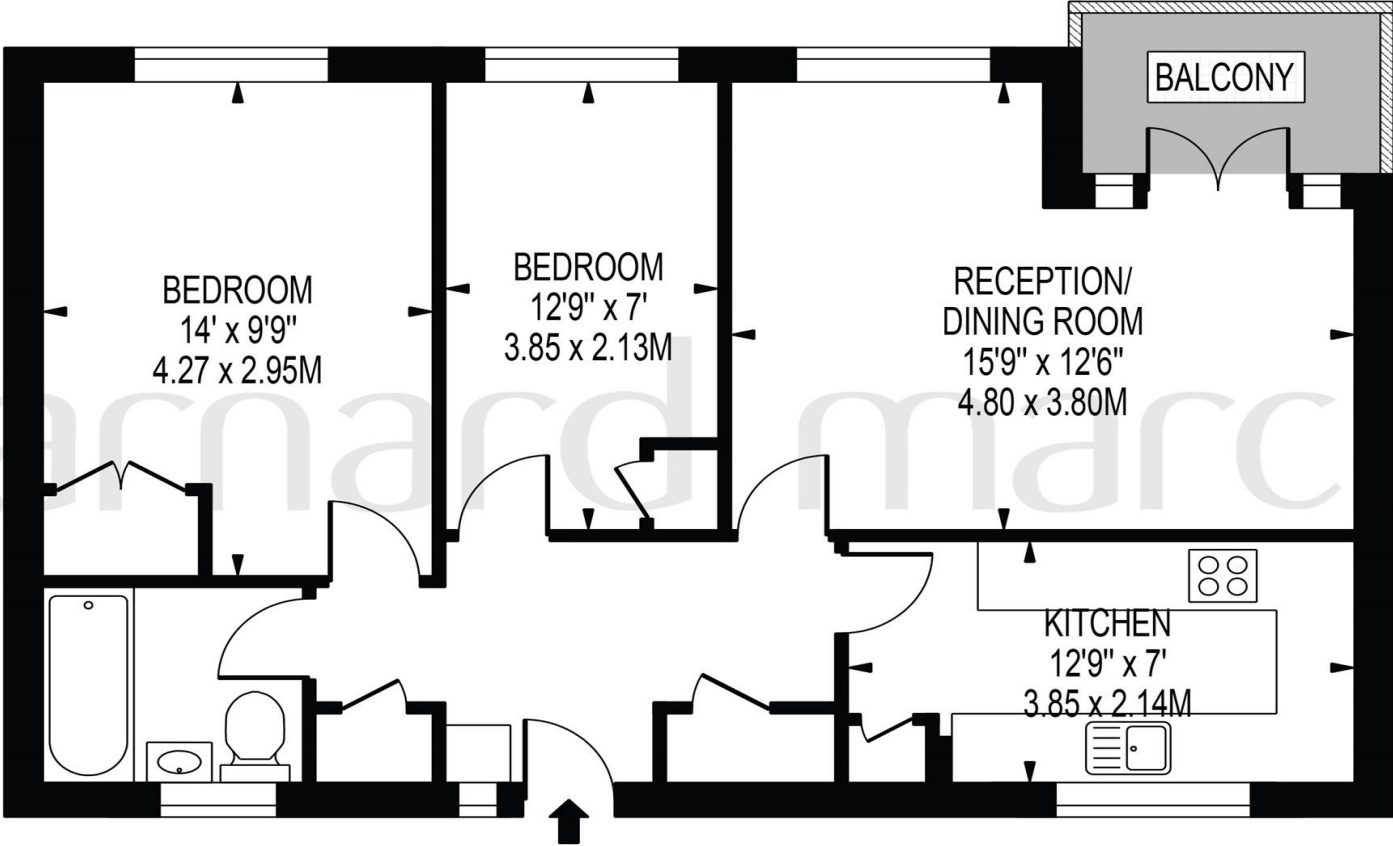
