



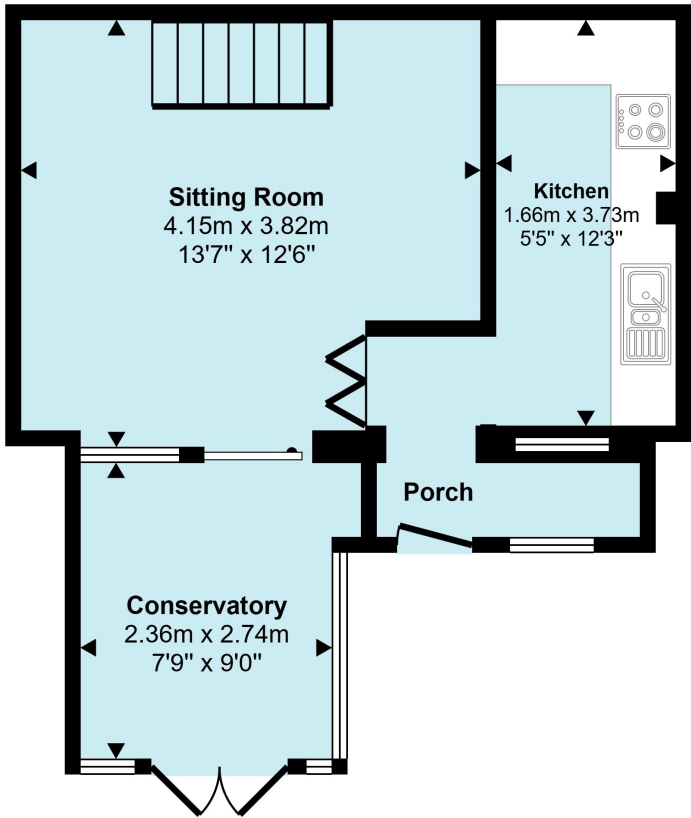

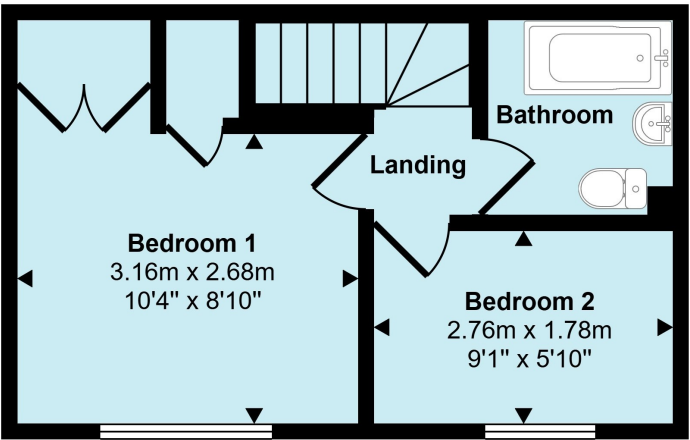

Description

Purley Drive is a two bedroom back-to-back property situated on the popular Bower Manor development benefitting from a tandem allocated parking space close by.

The property is offered with vacant possession and no onward chain.

THE PROPERTY:

The accommodation comprises an entrance porch and a sitting room with doors opening to the conservatory. The sitting room has a gas fire and stairs rising to the first floor. The kitchen has an integrated fridge and freezer and a gas hob.

To the first floor are two bedrooms and a family bathroom with an electric shower.

Outside – The garden is laid to patio with a garden shed and has been designed with low maintenance in mind.

As previously stated, there is tandem allocated parking a short walk from the property.

Please note that there is no hot water, and a new heating system will be required. The only hot water is the electric shower. Bearing this in mind this would make a fantastic first time buyers' residence and a viewing of it comes highly recommended.

LOCATION:

The property is situated on the east side of Bridgwater with good access to Junction 23 of the M5 motorway without passing through the town. The Bower Manor development boasts its own shopping facilities plus takeaway outlets and a regular bus service to the town. The property is situated approximately 1.5 miles from the town centre that offers an excellent range of facilities including retail, educational and leisure amenities. Main line links via Bridgwater Railway station are readily available. There are regular bus services to Taunton, Weston-super-Mare and Burnham-on-Sea plus a daily coach service to London Hammersmith from Bridgwater Bus station.
