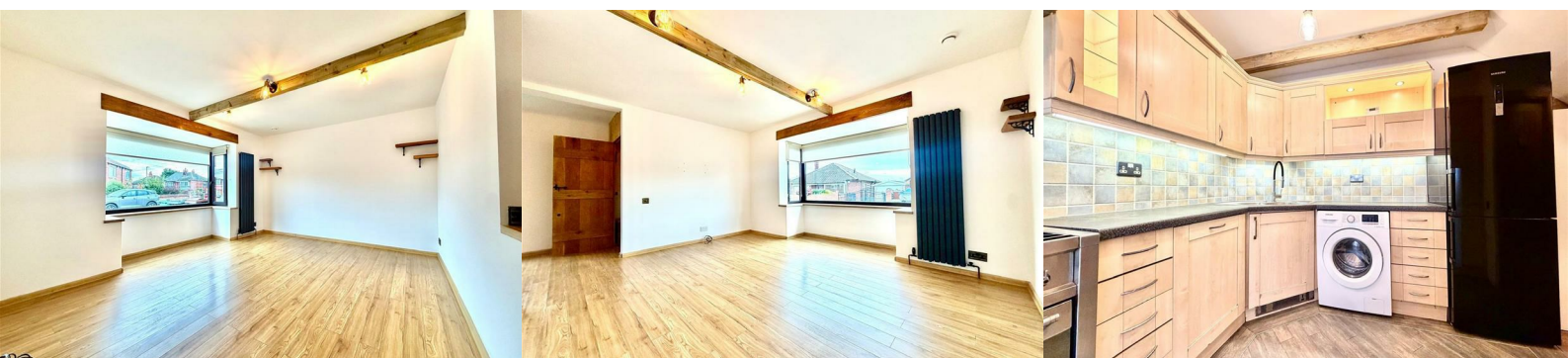

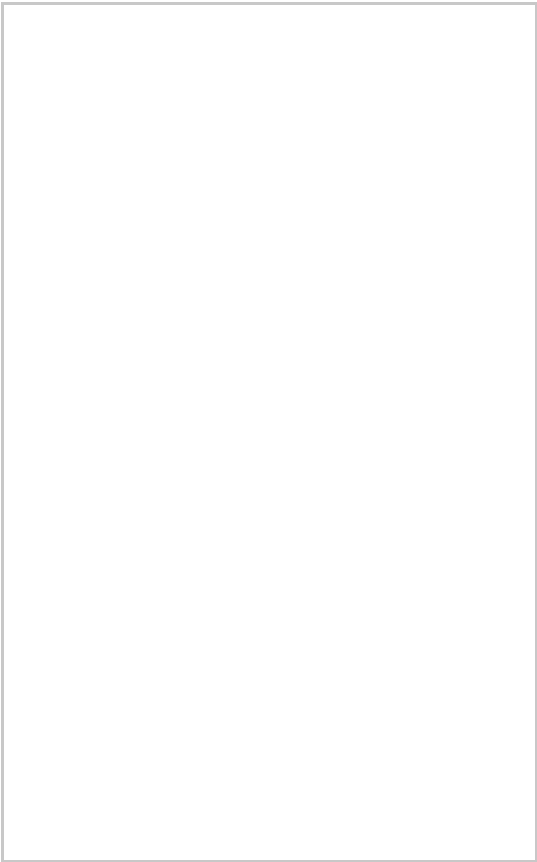

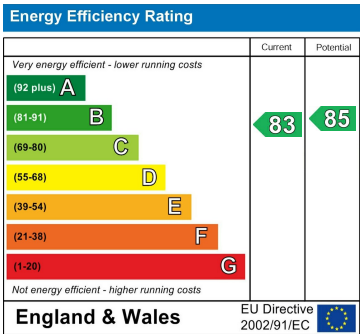
Area Map
