The ground floor features an entrance hall, cloakroom, a study/bedroom four, and a stylish open-plan kitchen/family room fitted with integrated appliances.

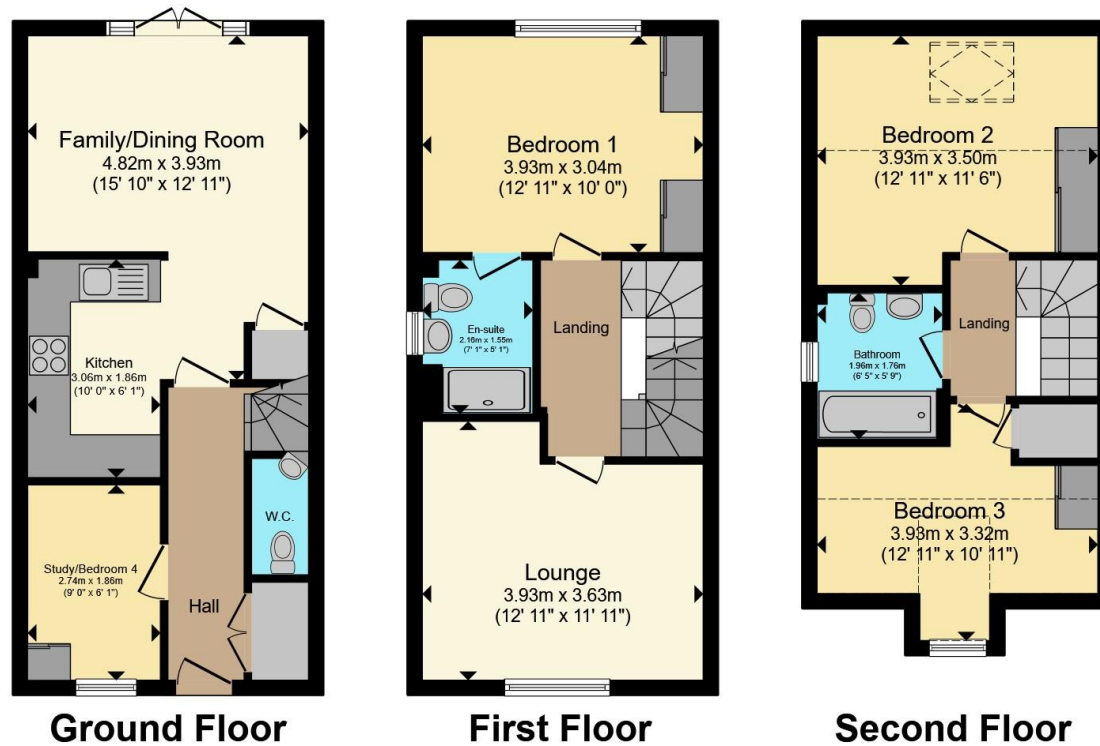
The first floor provides a generous lounge and a principal bedroom with en-suite shower room, including a high-specification Japanese-style toilet.
