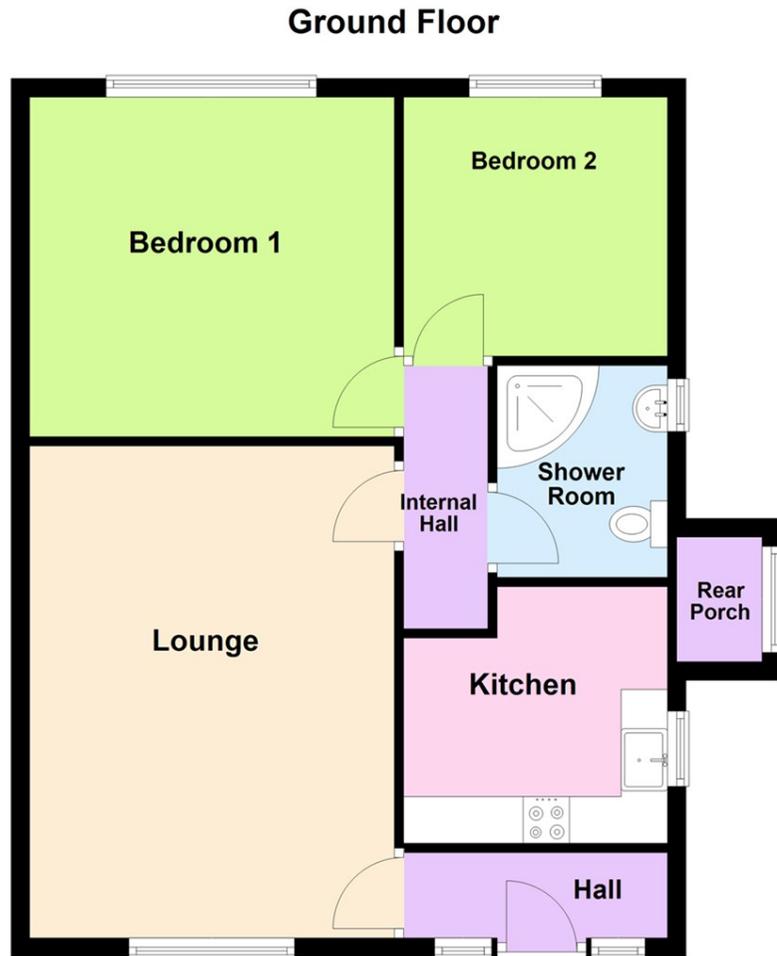

Floor Plan

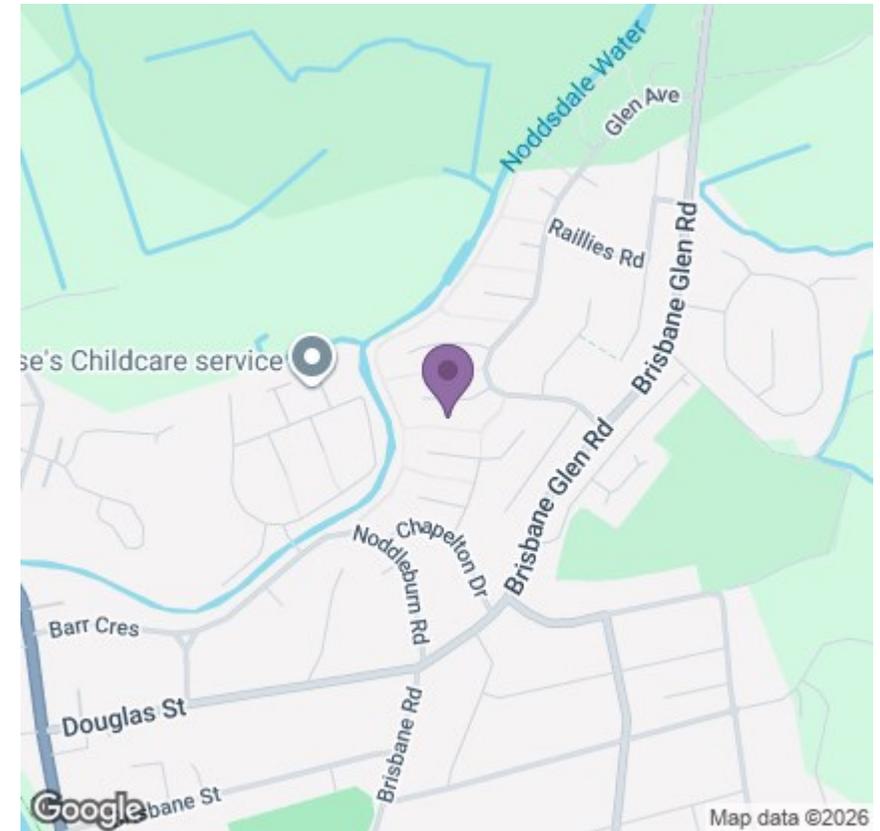
