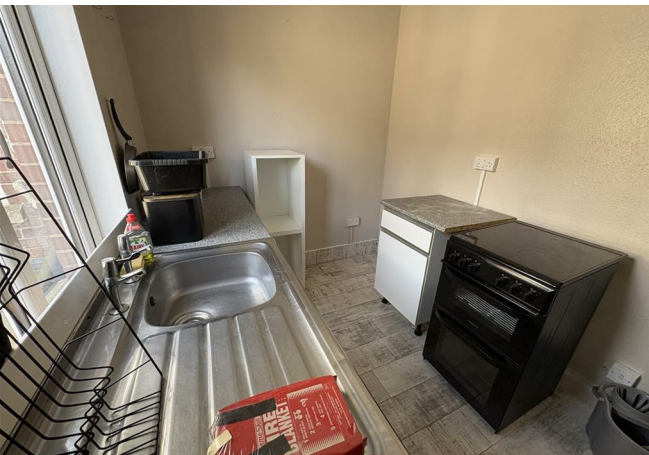

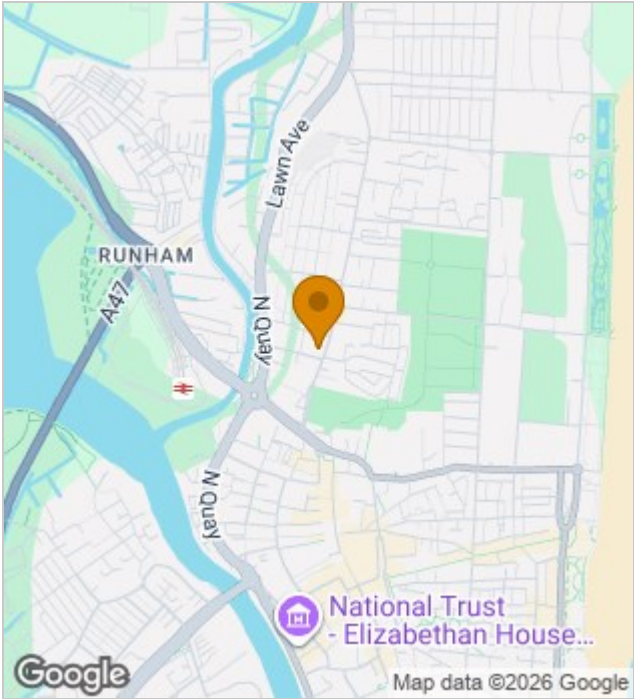
Council Tax Band

Council Tax Band A

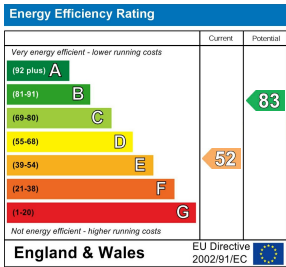
Floor Plans
