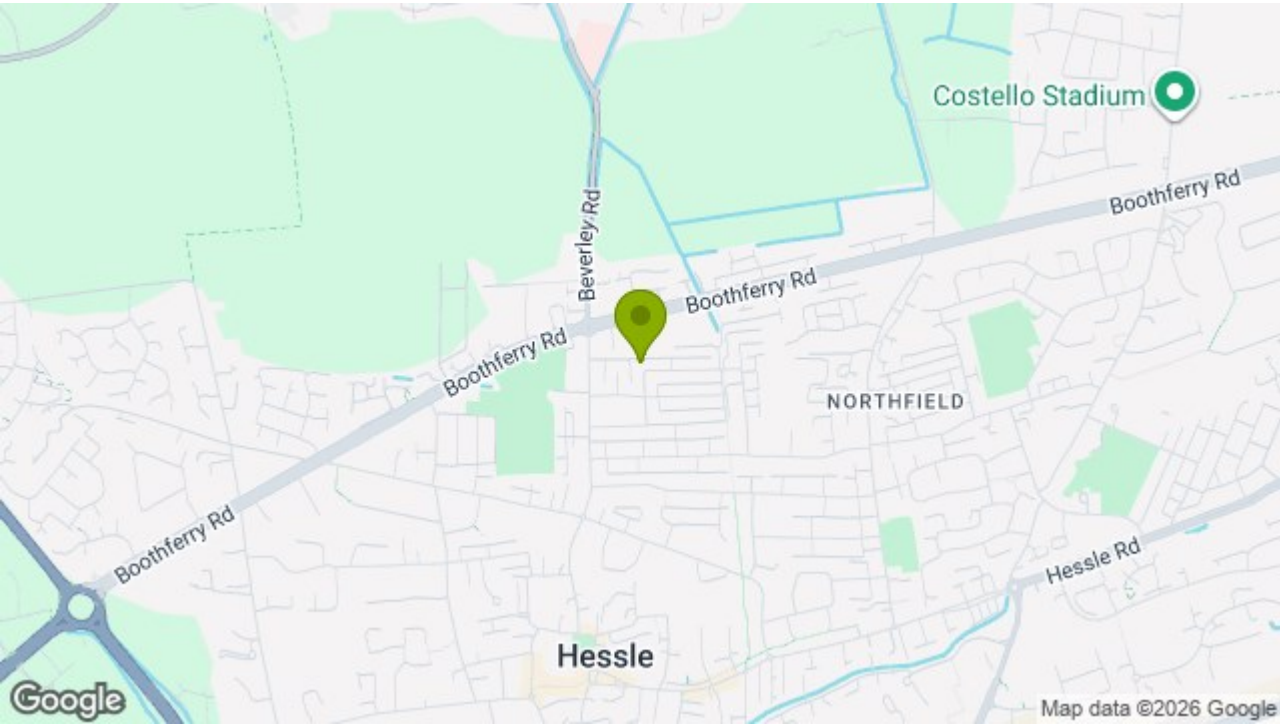
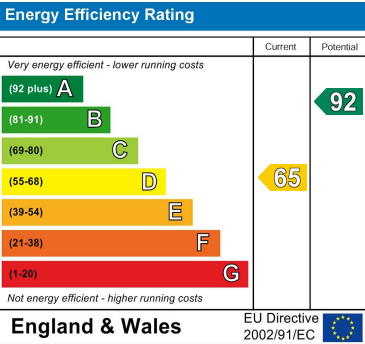
A superb two bedroom terraced property, beautifully presented throughout and a credit to the current owner.

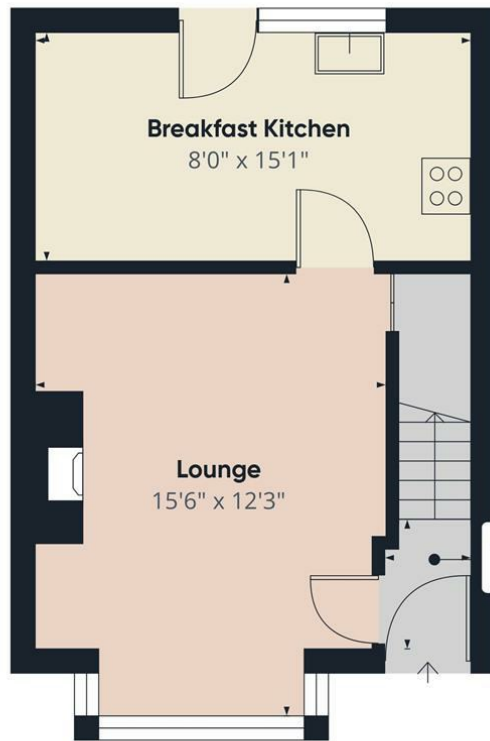
