Positioned on the edge of Weybourne in an elevated setting, this 4 bedroom semi-detached brick and flint property offers significant potential for refurbishment in one of North Norfolk's most sought-after coastal villages.

The property sits within large grounds backing onto agricultural fields, with open countryside views and occasional glimpses of the sea. Internally, the accommodation is arranged across 3 floors and currently offers flexible living space with multiple reception rooms or bedrooms, 2 kitchens, bathroom facilities on both the ground and first floors, and additional loft storage rooms on the second floor.

The property requires full renovation throughout, offering buyers the opportunity to modernise and reconfigure the space to suit their own needs and style.

Outside, there is a large driveway to the front providing parking for several vehicles, while the rear garden enjoys a private position overlooking surrounding fields.

Weybourne remains a popular coastal village with a village shop, pub and access to the beach and coastal path all within walking distance. Holt and Sheringham are both nearby, offering a wider range of shops, schools and transport links.
