A spacious five bedroom, three bathroom house set within a secluded private close in the heart of Hampstead.

Arranged over four floors and extending to approximately 2,754 sq ft, this well proportioned home has been thoughtfully modernised by the current owners. The ground floor features a convenient integral garage, a stylish eat-in kitchen leading onto a charming patio garden, and additional storage.

The first floor is centered around an impressive 32 ft reception room with a bay window, providing an ideal space for both living and entertaining, along with a contemporary WC/shower room. The second floor comprises three well-sized double bedrooms, a family bathroom, and additional storage.

The top floors hosts an indulgent principal suite with built-in storage and a generous en suite bathroom with both bath and shower, alongside a further double bedroom with access to a roof terrace offering wonderful views.

Tower Close is ideally located for the cafés, boutiques, and restaurants of Hampstead, Belsize Park, and South End Green. Belsize Park Underground station (Northern line) and Hampstead Heath Overground station are both approximately a nine-minute walk away.

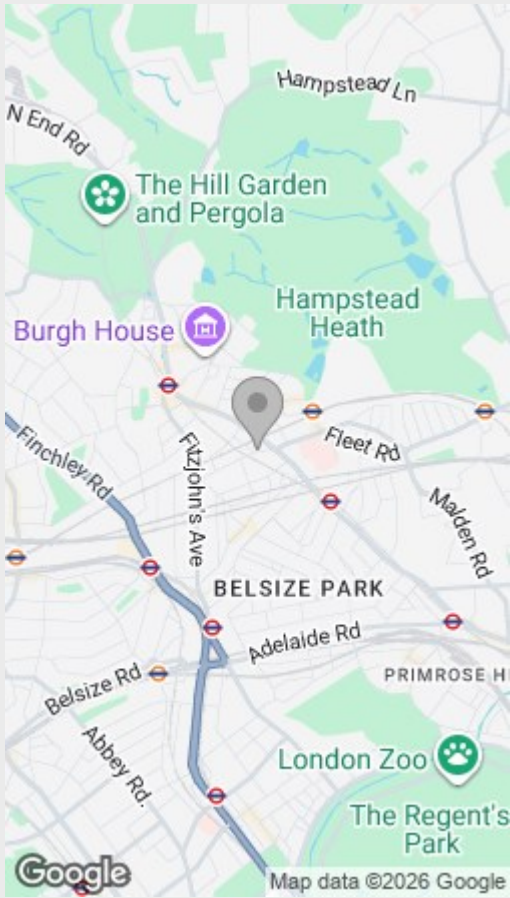

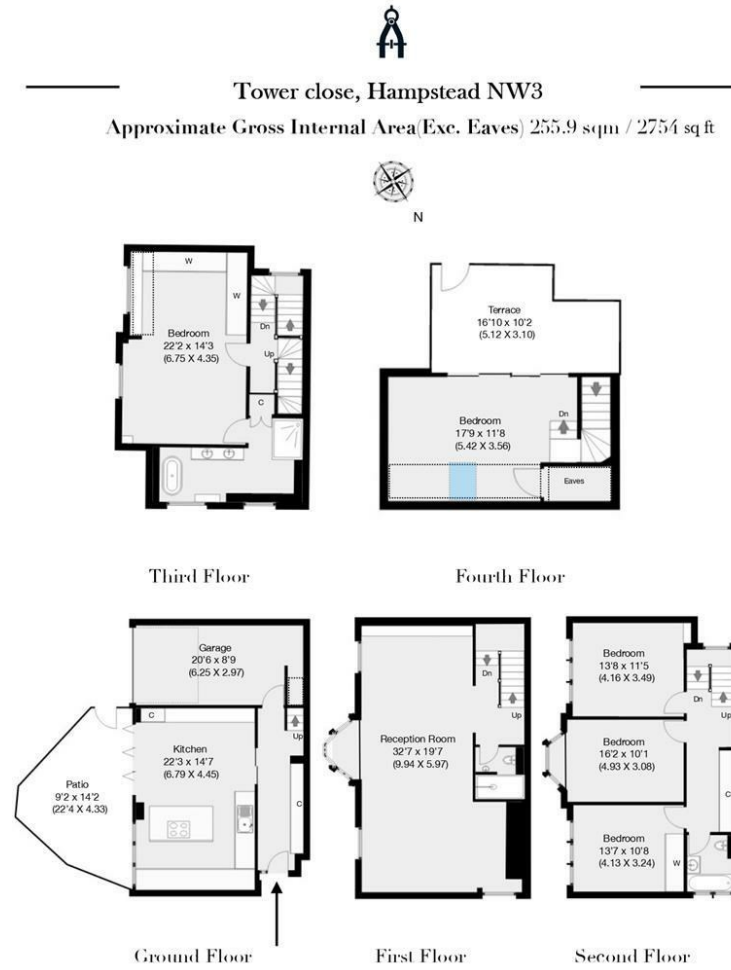
Floorplan & EPC

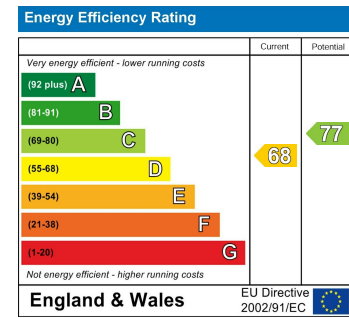
