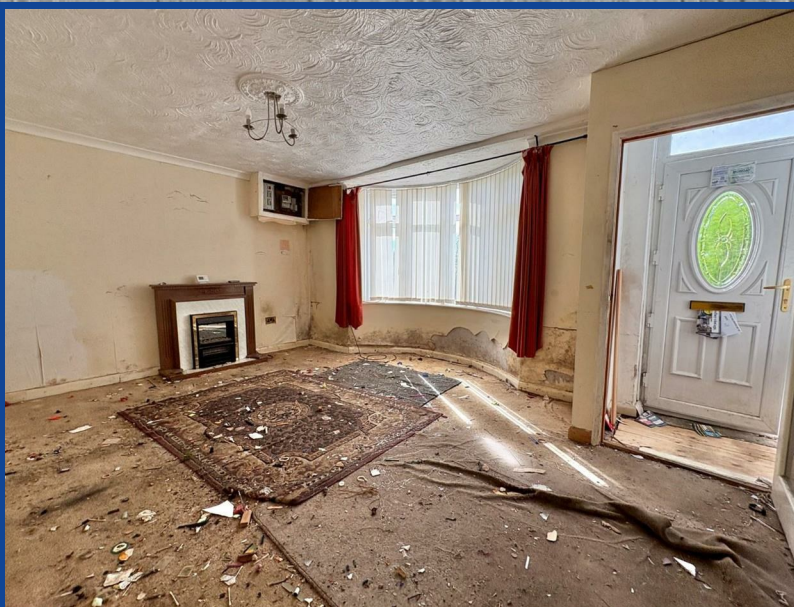

Situated on Valley Terrace in the popular village of Howden-le-Wear, the property is conveniently positioned for local amenities, including a primary school, post office/village shop and regular bus services. The surrounding area also provides easy access to the nearby towns of Crook and Bishop Auckland, together with the wider surrounding areas.

Modern Auction

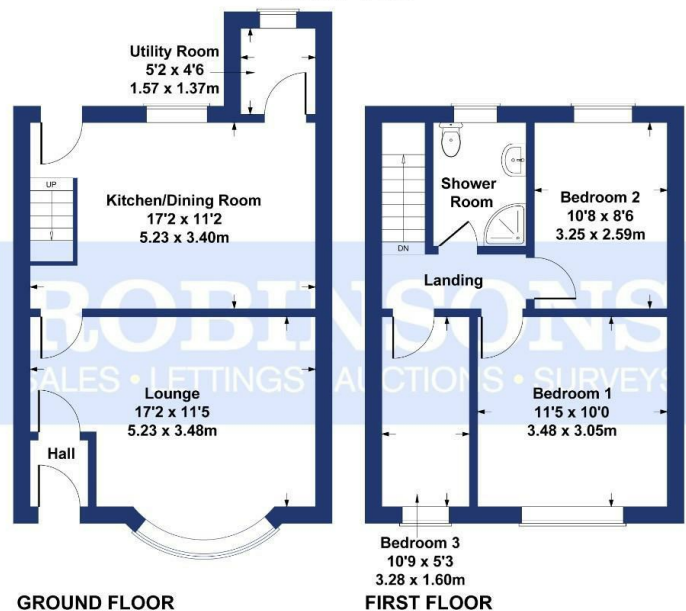
