Door to front, double glazed window to side, central heating radiator and stairs off.

Double glazed window to rear and central heating radiator.

Bedroom Three

Double glazed window to rear and central heating radiator.

Bathroom

Shower. WC, double glazed window to front, central heating radiator, wash hand basin with mixer tap and storage below and tile splash backs.

Referral Fees.

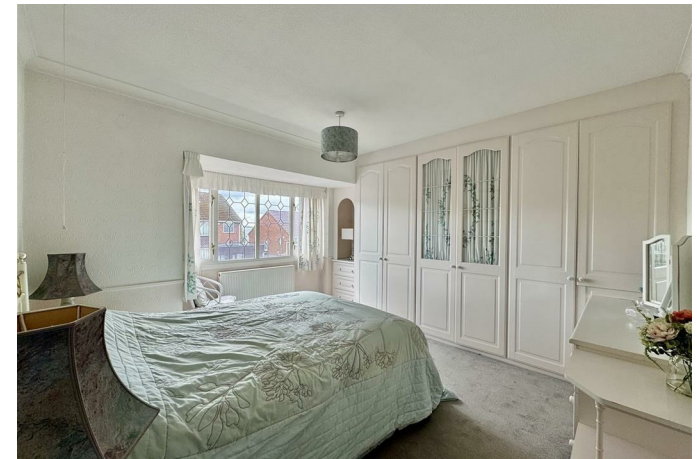

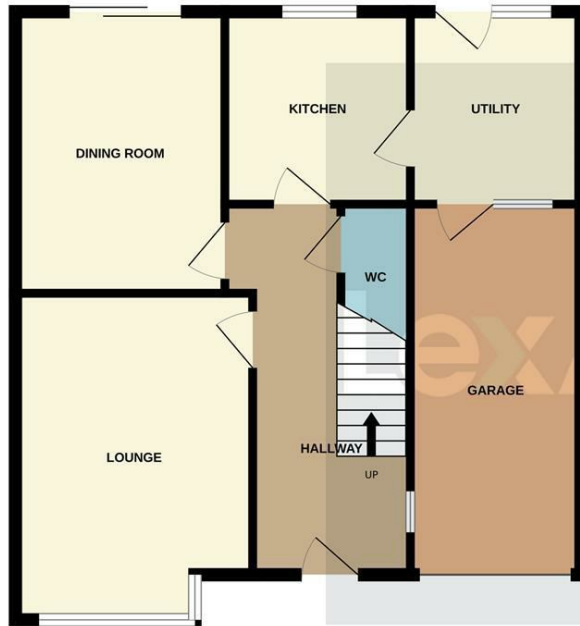
