Benefits include gas radiator central heating and uPVC double glazing however the property is in need of some refurbishment and redecoration. In addition the property also offers two double bedrooms, 9'9" x 8'4" first floor bathroom and a 25ft lounge/dining room. The accommodation briefly comprises porch, entrance hall, lounge/dining room, kitchen, landing, two bedrooms, bathroom, front and rear gardens and a double garage and off road parking.**
