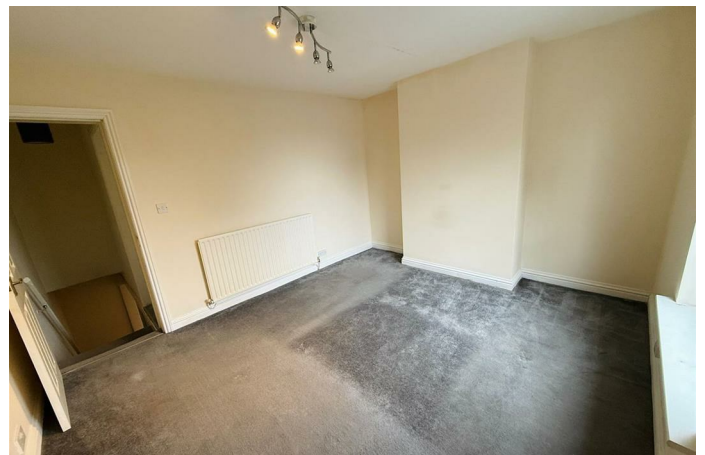
We require to see a passport for every adult or a copy of a birth certificate, along with proof of your address.
