Briefly, the accommodation comprises: lounge and dining kitchen to the ground floor. Two bedrooms and family bathroom to the first floor. To the rear of the property is an enclosed yard. This family home is uPVC double glazed and warmed via gas central heating. Early internal viewing is strongly advised.

Double glazed front entrance door opening into lounge. uPVC double glazed window to the front elevation with radiator beneath. Feature fire with attractive surround and hearth. Cupboard housing meters. Laminate flooring, light and power points.

KITCHEN 13'41 x 9'06

uPVC double glazed window to the rear elevation with sink and drainer unit beneath. Fitted with a range of wall and base units with complementary work surface, with inset four ring gas hob with oven beneath. Plumbing for washing machine and space for free standing fridge freezer. Wall mounted boiler. Protected splashback area and tiled floor. Radiator, light and power points. Door providing access to the rear garden.

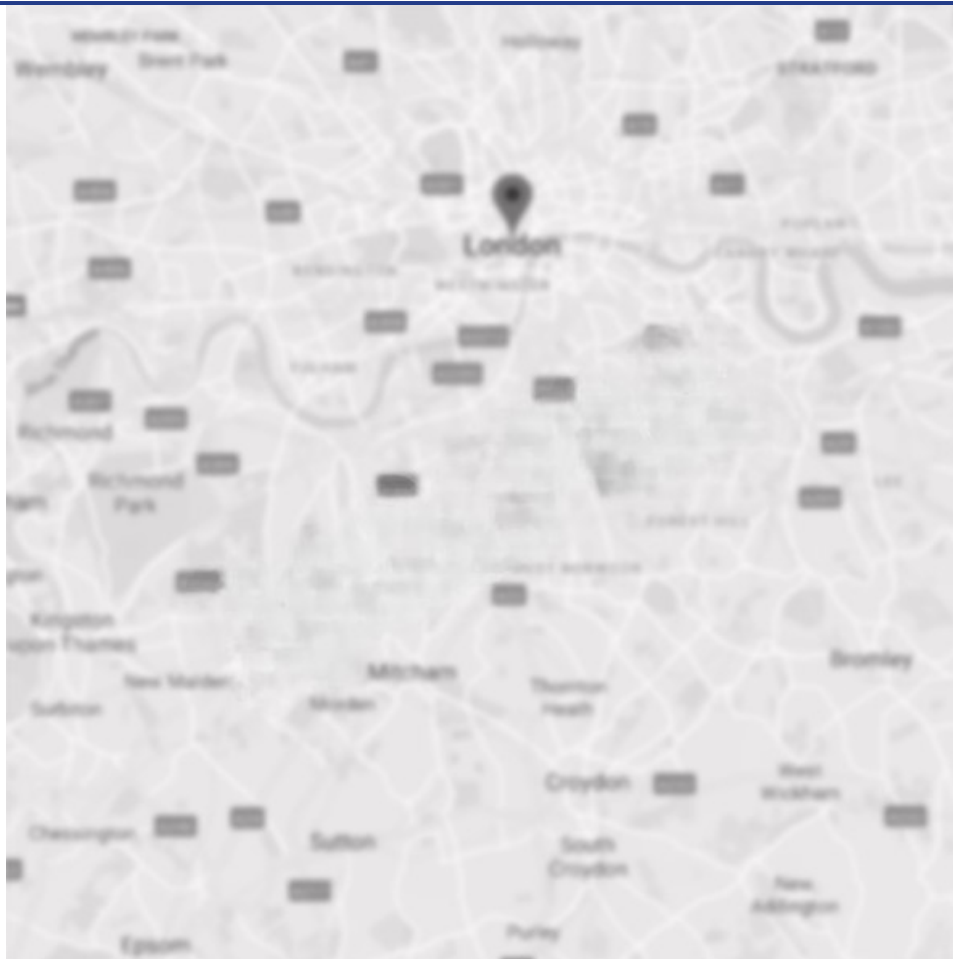

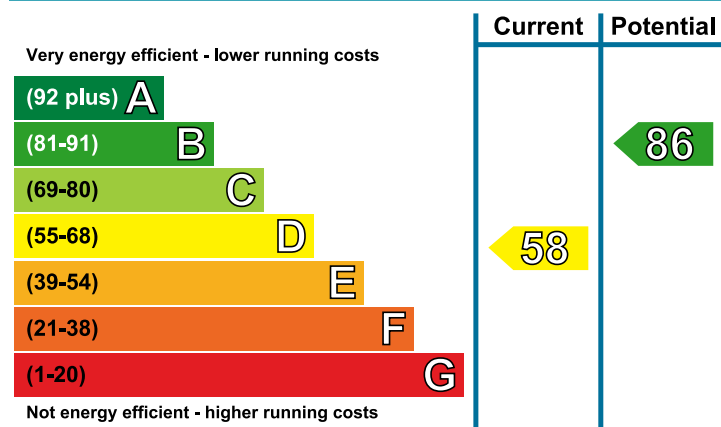

Financial Support and the Green Deal

About the impact of buildings on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in homes produces over a quarter of the UK's carbon dioxide emissions.

The average household causes about 6 tonnes of carbon dioxide every year. Based on this assessment, your home currently produces approximately 3.7 tonnes of carbon dioxide every year.
