



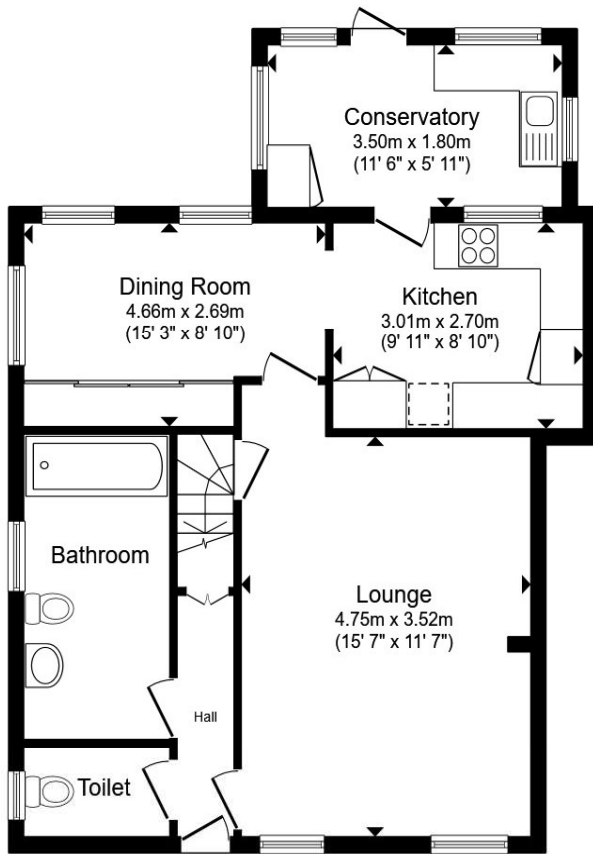

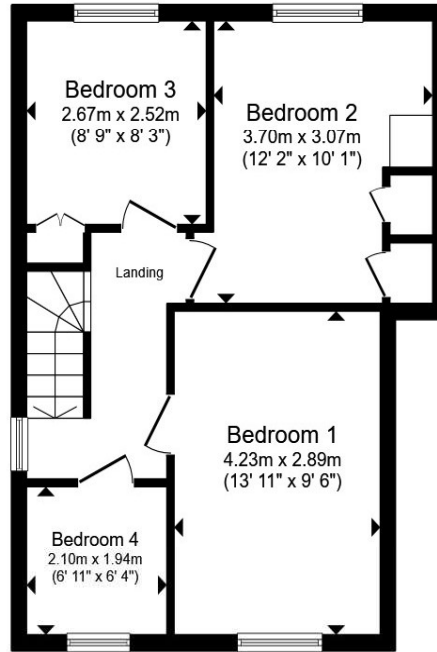

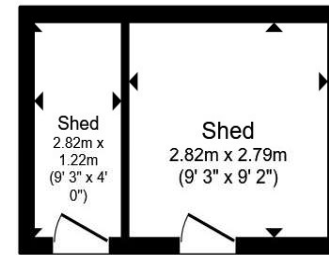




Ground Floor

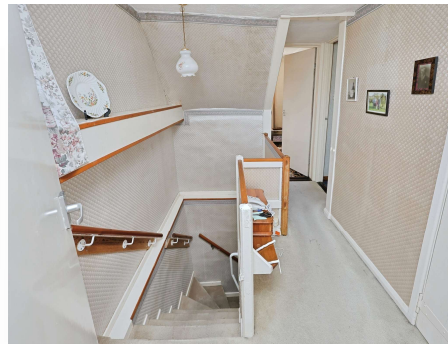
