ACCOMMODATION:

The apartment comprises an entrance hall with entry phone system, a good-sized double bedroom and a modern shower room with a large walk-in shower. The bright and comfortable living room has sliding doors opening onto a private balcony both of which have been replaced in early 2026, while the well-appointed kitchen is fitted with an integrated electric oven and inset four-ring electric hob, washing machine and freestanding fridge/freezer.

OUTSIDE:

The property benefits from an allocated private parking space situated towards the rear of the block, together with use of the well-maintained communal gardens.

SITUATION:

The property is in a popular and central road in the centre of Tunbridge Wells. The Royal Victoria Place Shopping Centre and Calverley Road pedestrianized precinct are a short distance away. The main line railway station at Tunbridge Wells, High Brooms, the Pantiles and the old High Street, are within walking distance offering a wide array of independent retailers and restaurants, many of which help define Tunbridge Wells as the unique town it is. Furthermore the facility enjoys good areas of greenery including St Johns Park and Grosvenor and Hilbert recreation grounds. There are a number of well regarded
