The area is noted for its country pursuits and is particularly popular amongst walkers and equestrians for riding out purposes. Local amenities are available in the nearby village of Llansilin, which is quite popular and only some 10 minutes driving distance off Rhiwlas. A comprehensive range of amenities can be found in Oswestry, including a wide range of shops, social and leisure facilities together with schools. From Oswestry, commuters then have easy access along the A5 to Shrewsbury or alternatively North with road links to Wrexham and Chester.

Dual aspect letting in natural light.

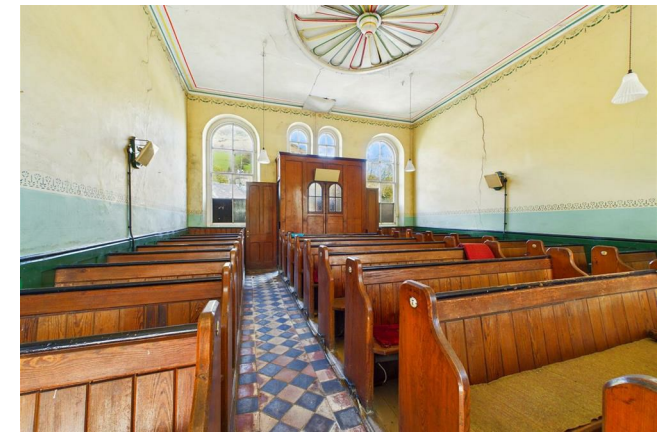
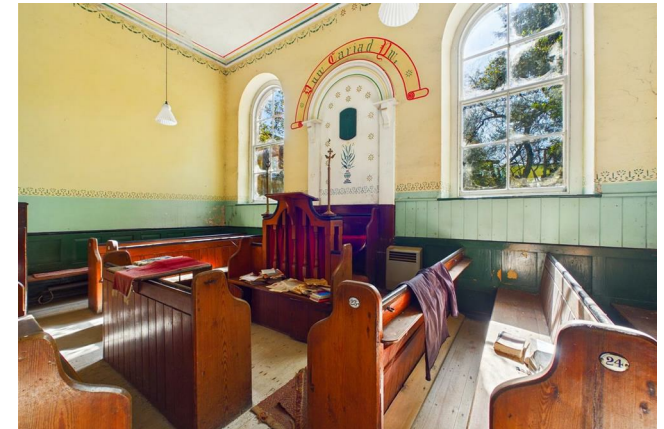
## VESTRY

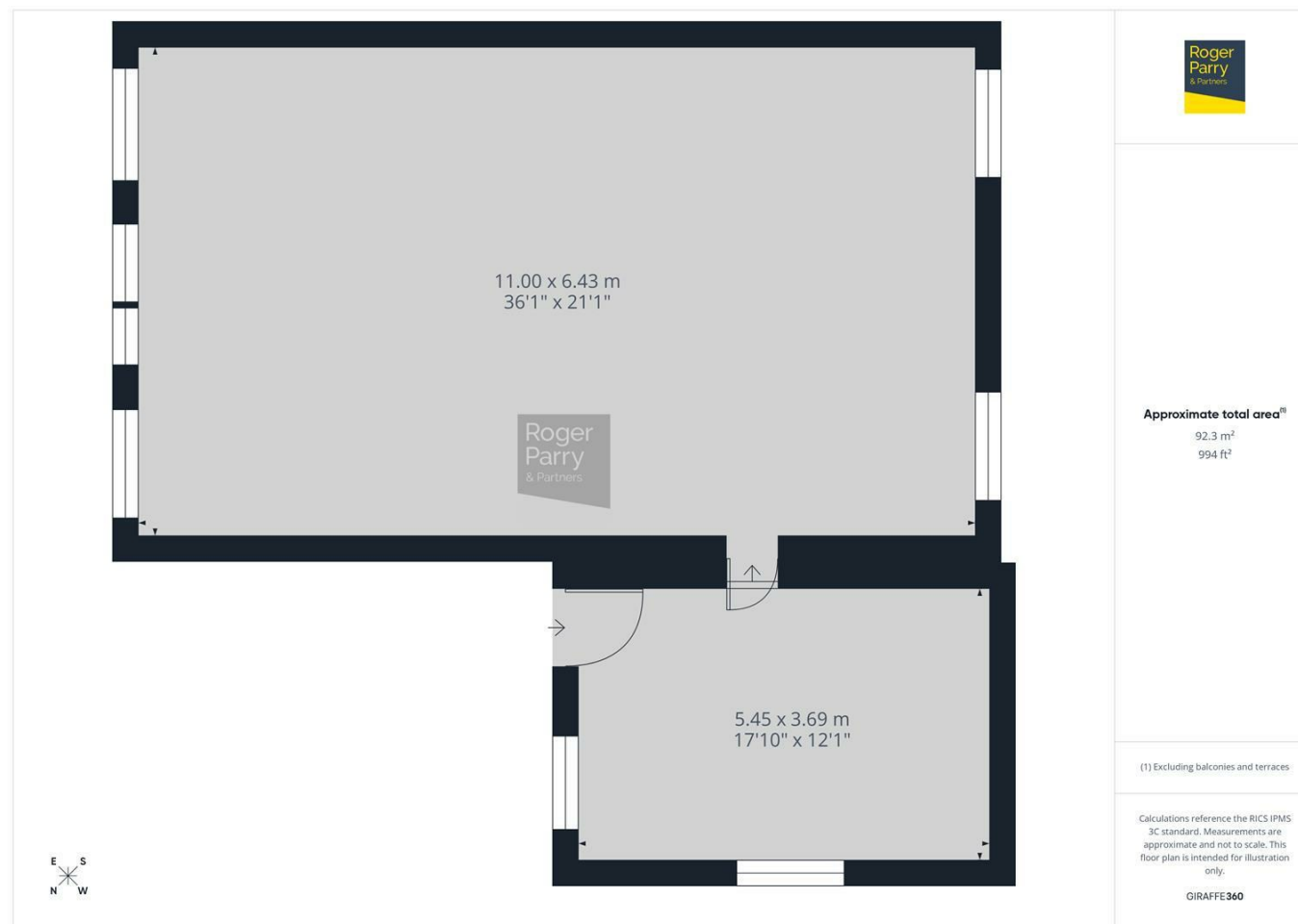
