Double glazed window to front, radiator, coved ceiling, fireplace with flame effect gas fire and back boiler, glazed double doors to kitchen/diner.

Fitted with matching base and wall cupboards with tiled splash backs, 1½ bowl sink unit, gas hob and electric oven with extractor hood above, space for washing machine and fridge/freezer, radiator, coved ceiling, tiled floor, double glazed window to rear.

Comprising of panelled bath with mains shower, wash hand basin, part tiled walls, tiled floor, radiator, extractor fan.

Coved ceiling, attic access.

Two double glazed windows to front, two radiators, coved ceiling, fitted wardrobes.

Bedroom 2 13'5" x 8'0" (4.10 x 2.44)



Double glazed window to rear, radiator, coved ceiling, fitted wardrobe.

Bedroom 3 9'11" x 9'5" (3.03 x 2.89)



Double glazed window to side, radiator.

WC, wash hand basin, part tiled walls, tiled floor, extractor fan.

Outside


Small enclosed rear courtyard.
