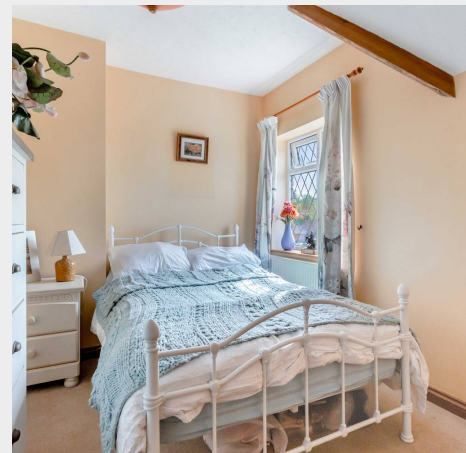




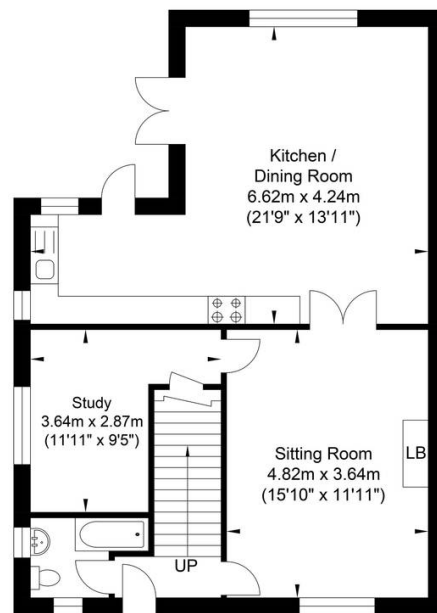

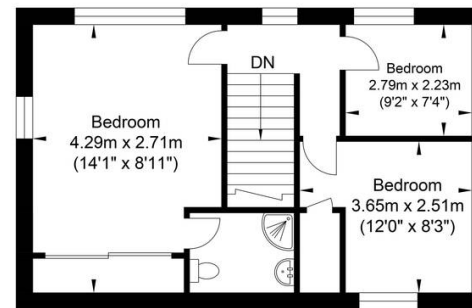
Hadlow Down has a primary school, picturesque church, village hall, village inn and Wilderness Wood which boasts a tearoom and playground. Buxted village is within short driving distance and offers a local store, a railway station with services to London (London Bridge: 67 minutes approx). The market town of Crowborough, Uckfield and Heathfield are about five miles and offer a comprehensive range of shopping and leisure facilities. The area is well served for a range of primary and secondary schooling both in state and in the private sector. The nearby A272 offers a swift access towards Haywards Heath which not only offers a fast and regular railway service to London (Victoria, London Bridge) both approximately 47 minutes but provides access to the nearby A/M23 into London. The picturesque Ashdown Forest is within a short drive and offers scenic walks and bridlepaths. The coastal towns of Brighton, Eastbourne and Hastings are all within 25 miles.
