DESCRIPTION

Shardeloes Court offers a communal residents lounge and kitchen, guest suite accommodation for visitors and central laundry facilities, all located on the ground floor. There is an on-site warden assistance service which operates during normal working hours with emergency off-site support provided out of hours.

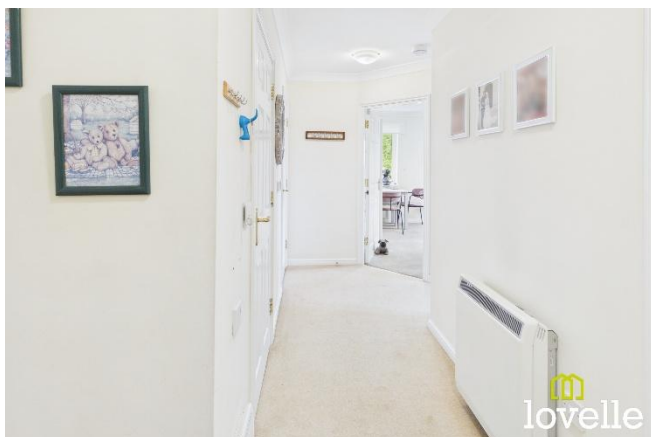
Located on the third floor, this well-presented accommodation is behind a private fire door from the main landing where you enter into a spacious central Hallway. From the central hall there are doors leading through to the spacious lounge/diner with separate kitchen, bedroom, bathroom and two large airing storage cupboard.

The apartment benefits from a monitored emergency call system which is attended by the on-site warden during working hours and is monitored remotely out of hours, providing 24 hour support for residents in an emergency.

This apartment is flooded with natural light with two windows in the living / dining area. To the left is the kitchen with contrasting work tops and a mixture of wall and base units, electric hobs with an extractor unit. There is a window to the side elevation to allow for natural light.

There are two bedrooms, one with mirrored fitted wardrobes and both the windows to the side elevation, supported by a bathroom including a walk in shower, WC, basin, heated towel rail and storage unit.

PARTICULARS OF SALE

Hallway

4.37m x 1.2m (14'4" x 3'11")

From the entrance door into the main landing where you find the spacious central Hallway. There are doors leading through to the spacious lounge/diner with separate kitchen, two bedrooms, a bathroom and two airing / storage cupboard.

Bedroom One

The double bedroom consists of a mirrored fitted wardrobe and free standing units, with the window to the side of the elevation. Neutrally decorated throughout.

Bedroom Two

4.8m x 2.51m (15'8" x 8'2")

The second bedroom is another good size, with free standing wardrobes and the window to the side elevation.

Living Room

5.14m x 3.49m (16'11" x 11'6")

The living / dining room is flooded with natural light with two windows in the room and an electric fire, spacious with enough room for living and dining, with a separate door at the side to enter the kitchen.

Kitchen

2.79m x 1.76m (9'2" x 5'10")

The kitchen offering contrasting work tops with a mixture of wall and base units, an electric oven and electric hobs with an extractor unit. With a window to the side of the elevation for extra light and air flow.

Bathroom

2.05m x 1.66m (6'8" x 5'5")

The bathroom consists of a walk- in shower with handrail, vanity unit with basin and mirror. There is also a WC with an additional handrail.

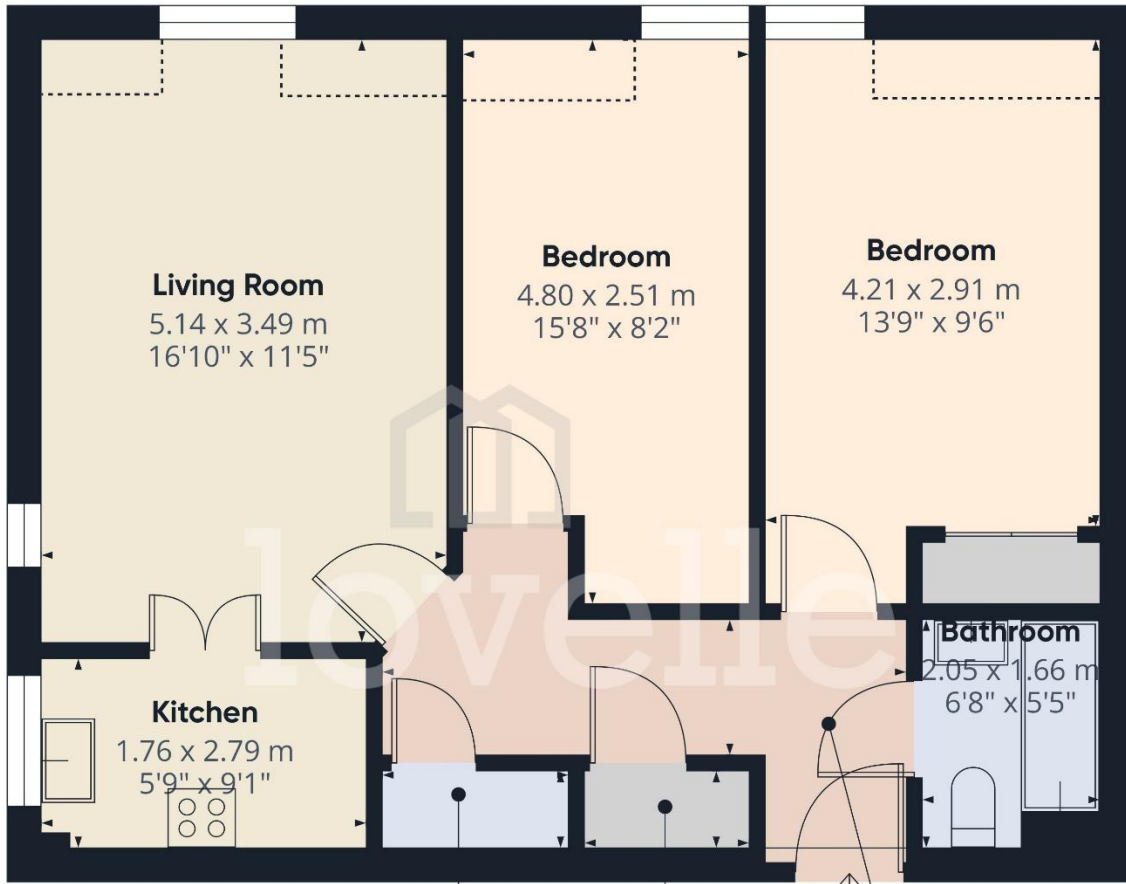
