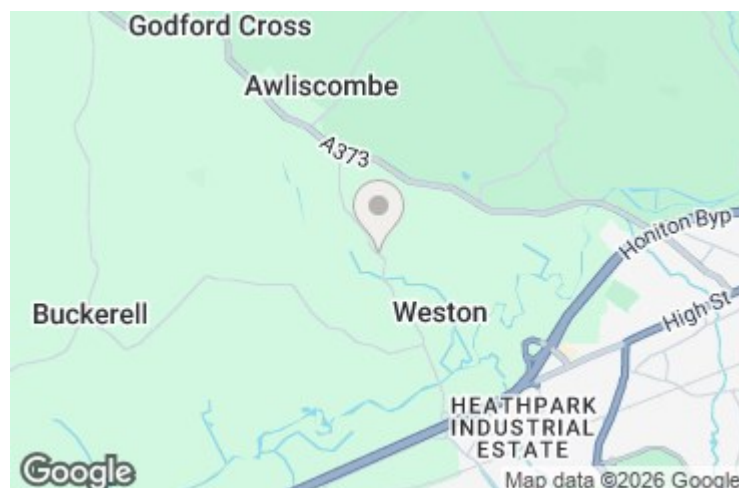

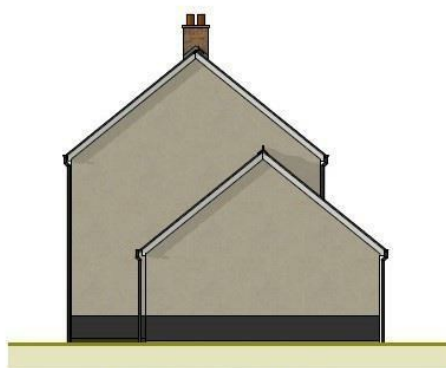
2026 CHARITY OF THE YEAR

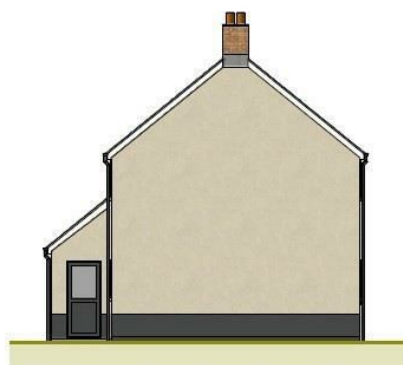
North West Elevation. Scale 1:100



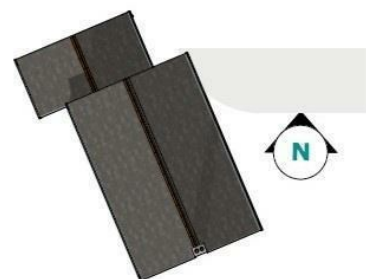
North East Elevation. Scale 1:100
