AT A GLANCE

A three-bedroom, mid-terrace cottage with a long enclosed garden and views towards the village church, offered for sale by informal tender with no onward chain.

DESCRIPTION

2 Offield is a traditional cottage situated in the heart of Holbeton, providing approximately 79.6 sq m (857 sq ft) of accommodation arranged over two floors.

The entrance hall opens to a well-proportioned sitting room with a wood-burning stove, while the kitchen offers space for everyday dining. A bathroom is positioned at the rear of the ground floor. Upstairs are three bedrooms and a separate WC, giving the cottage a practical layout that differs notably from its neighbour.

The property would benefit from refurbishment and updating, allowing a purchaser to shape the accommodation to suit their requirements.

Outside, the long enclosed garden is bordered by mature planting and an attractive old boundary wall, with views across the village towards the church spire. Its central setting, adaptable accommodation and generous garden make this an appealing village home with considerable potential.

LOCATION & SITUATION

Holbeton is an established South Hams village surrounded by rolling Devon countryside and situated close to the River Erme and the South Devon coast. Local amenities include a village shop, public house, primary school, parish church and village hall. The surrounding countryside and coastline provide numerous walking and recreational opportunities, while Plymouth is accessible by road for a wider range of shopping, leisure and transport facilities.

Directions

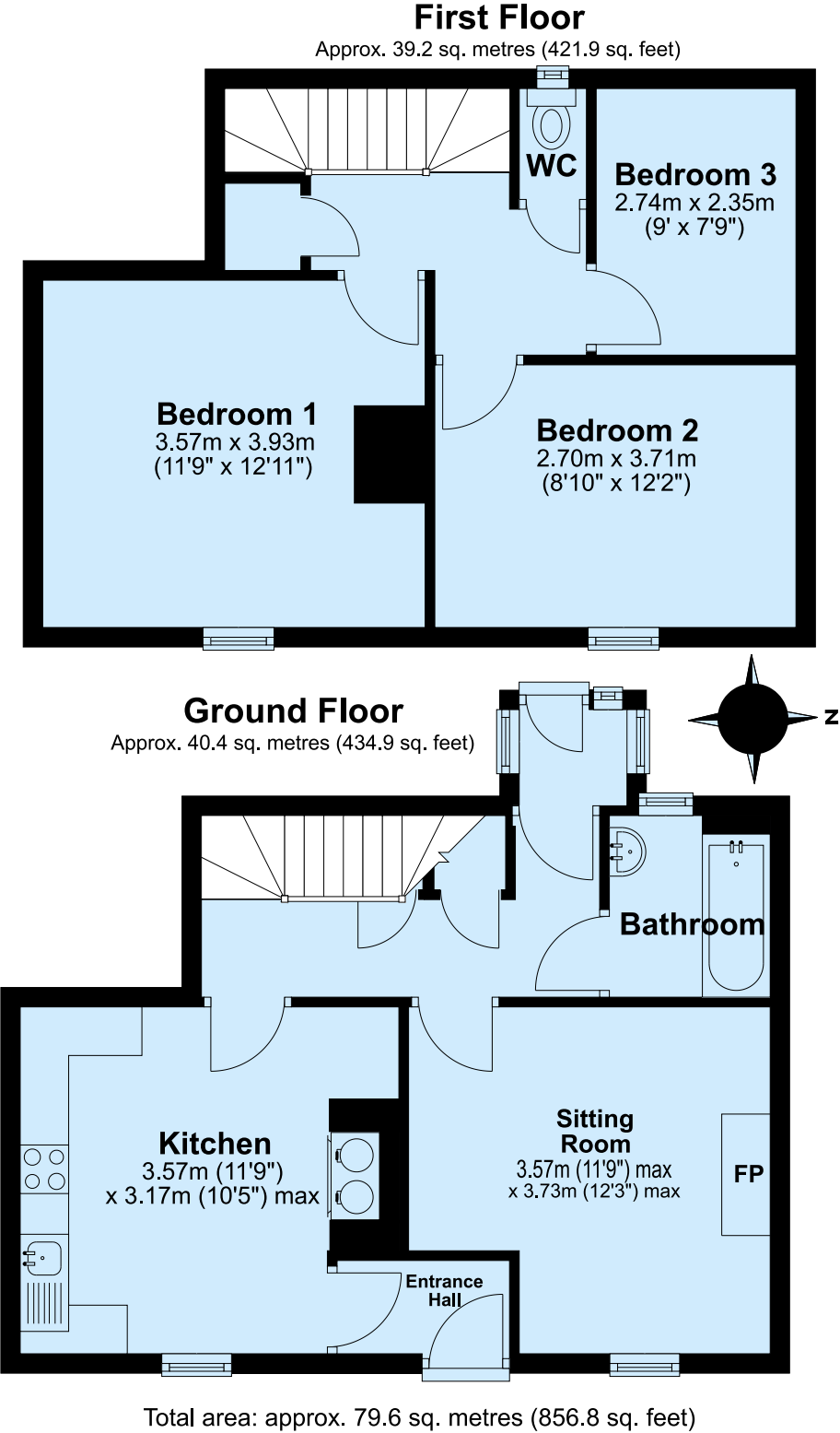
