### **Entrance Hall**

Double-glazed door to the front, stairs to the first floor and under stairs storage. Doors to the kitchen, lounge/diner and the cloakroom.

### **Cloakroom**

Corner, pedestal wash hand basin and low-level WC. Radiator and space for a tumble dryer.

### **Lounge / Diner**

'L' shaped with a TV point, radiator and space for a dining table and chairs. Double-glazed window to the rear and double-glazed door leading out to the garden.

### **Kitchen**

Fitted with a mix of wall and base units with work surface over, 1.5 bowl stainless steel sink with mixer tap and drainer, electric oven and gas hob with a chimney style extractor fan over. Space for a dishwasher, washing machine and a fridge/freezer. Double-glazed window to the front.

### **First Floor Landing**

Stairs from the ground floor and a storage cupboard. Doors to all bedrooms and the family bathroom.

### **Bedroom One**

Radiator and double-glazed window to the rear.

### **Bedroom Two**

Radiator and double-glazed window to the front.

### **Bedroom Three**

Bulk-head, radiator and double-glazed window to the front.

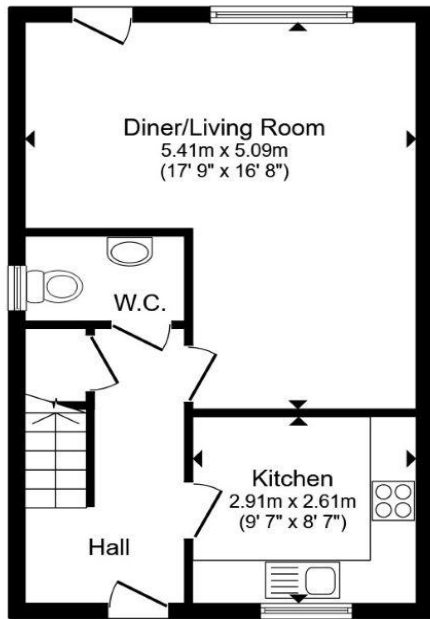
### **Bathroom**

Partially tiled with a pedestal wash hand basin, low-level WC and a bath with a shower over. Heated towel rail and a double-glazed obscured window to the rear.

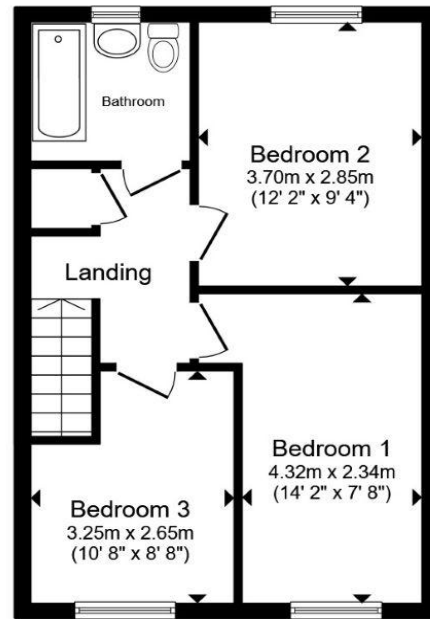
### **Rear Garden**
