



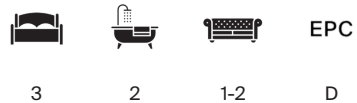

The upper levels comprise a generous principal suite occupying the entire first floor, with two further double bedrooms and a family bathroom situated on the top floor.

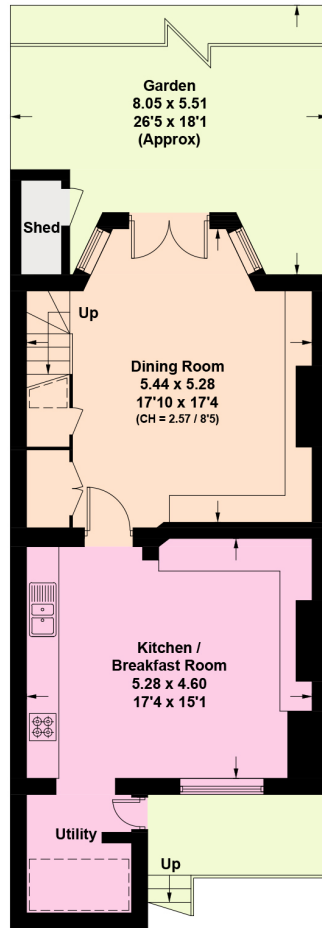




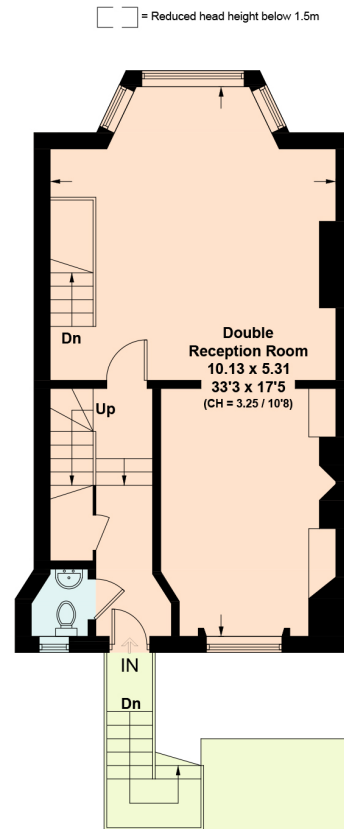

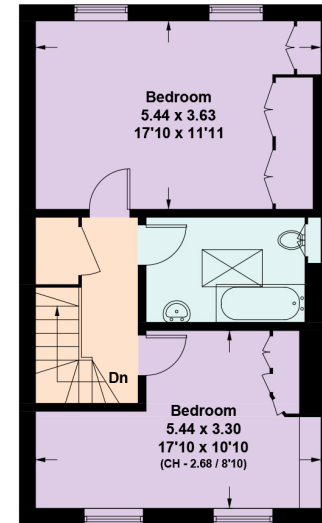
Lower Ground Floor
