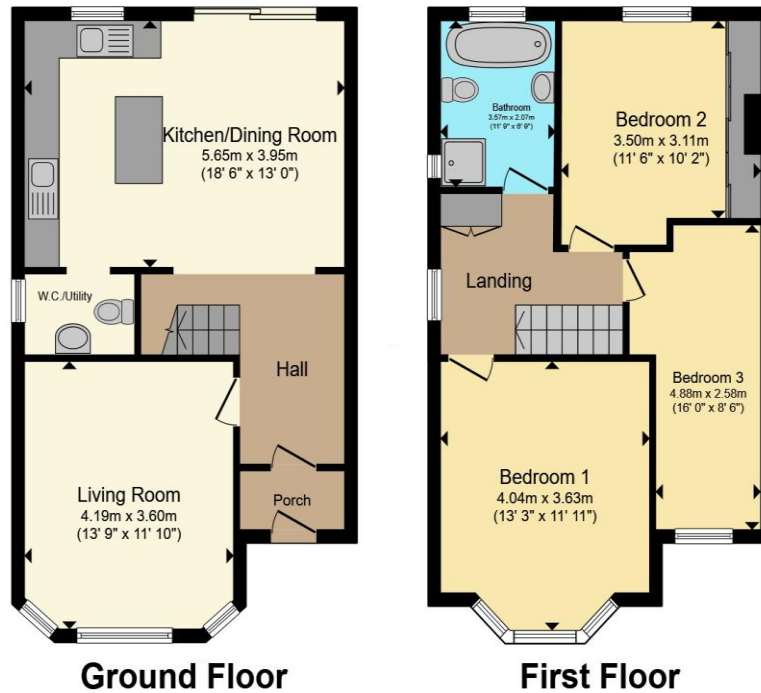
Manor Way
