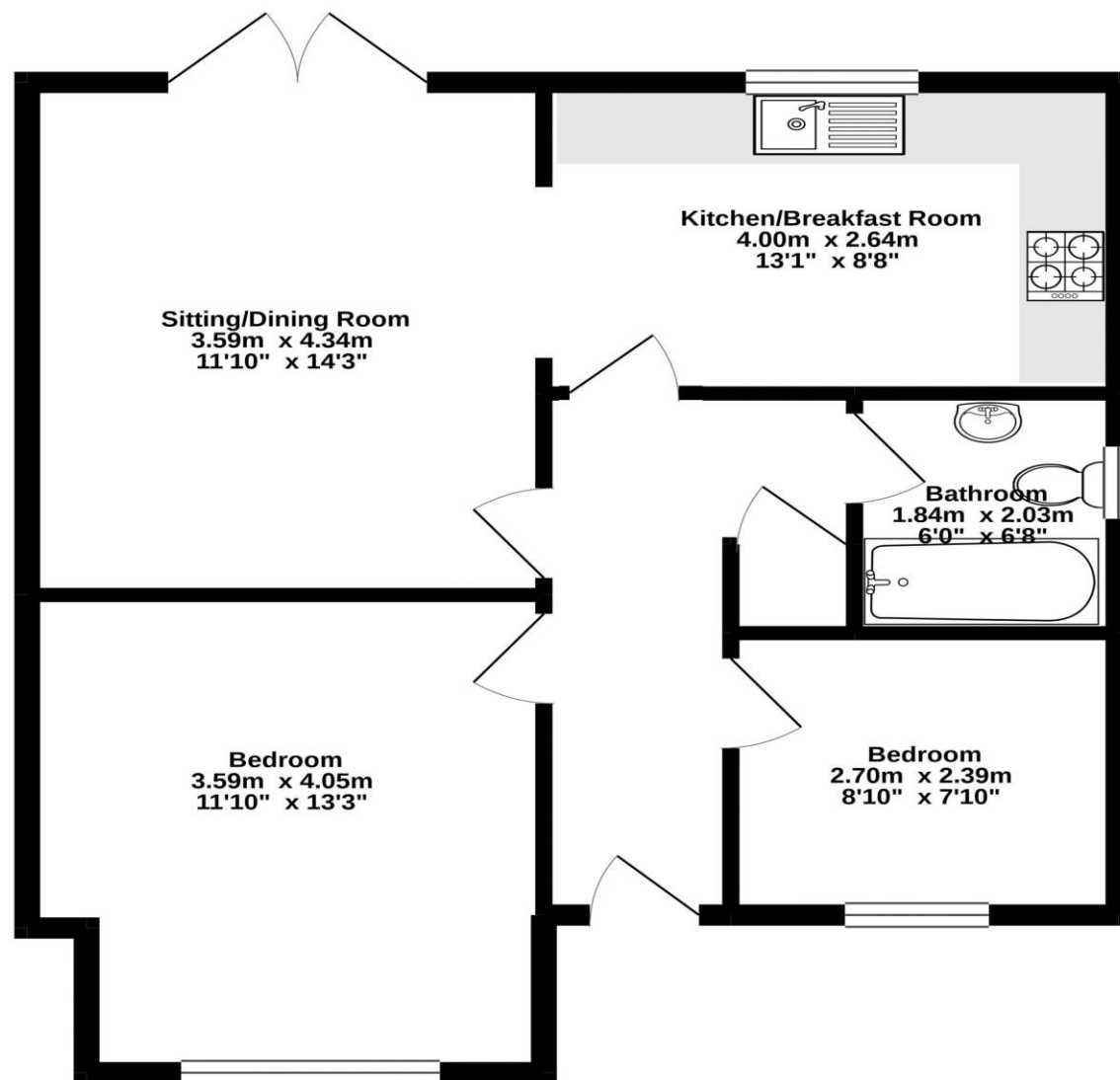

A two bedroom detached bungalow forming part of an exclusive development of just seven properties set in a tucked away position yet within walking distance to the centre of Wiveliscombe. Constructed in 2020 using traditional methods by a local reputable builder, the property benefits from the remainder of its 10 year builders warranty with ICW. The bungalow is warmed by gas fired central heating and is offered to the market with no onward chain.

The accommodation comprises in brief; front door opens into the entrance hallway with doors to all rooms. The sleeping accommodation lies to the front of the property and comprises two bedrooms which are serviced by the family bathroom, fitted with a white three piece suite.

To the rear, there is a large open plan sitting/dining room which leads through directly into the kitchen. The kitchen itself is fitted with a comprehensive range of wall and base units with an integrated oven and hob. French doors open from this area through to the garden, creating the ideal space to entertain. In addition, there is a fully boarded large loft space with windows and a drop-down ladder.

Outside, the property is approached via a shared driveway with private driveway parking to the side of the bungalow for two vehicles. A side gate opens through to the rear garden which enjoys a South Westerly aspect and is laid to both lawn and patio. To the front of the property, there is an additional area of lawned garden.
